

We refer to the above SID Planning Application Ref. 61.PA.0033.

An Bord Pleanála letter dated 29/9/15 invited the applicant to provide a written request for any item which requires clarification.

As requested by that letter the Phase 1 Compensatory Report was formally submitted to an Bord Pleanála on 24/11/15. The Planning Application itself was first lodged on 10.01.14.

Your letter of 21/04/16 indicated that there would be progress by response from 'DAHG' by 24/05/16 and that there would be meetings between the parties thereafter.

To date we have not been notified of any progress and the Applicant remains most anxious to progress this SID / Planning Application potential first IROPI case in this jurisdiction, which is essential to the survival of Galway Port and for the benefit of the region.

The clarifications that we request are therefore as follows :


- 1) What is the progress to date by you with DAHRRGA?
- 2) What is the consideration of the compensatory proposal submitted?
- 3) What is the timeframe and further steps proposed to progress the compensatory proposal to allow the planning process progress, in accordance with tight control of the timeframe proposed by yours of 29/09/15.
