Dear Sirs,

We refer to your letter of 13th October 2017 inviting Galway Harbour Company (GHC) to proceed to Phase 2 of the preparation of "compensatory measures" and also requesting a draft programme for the preparation of it's detailed proposals.

GHC responded on 2nd November 2017 advising:-

"We wish to confirm that we wish to proceed to Phase 2 as soon as possible"


We also confirm that a meeting was held with representatives of GHC and National Parks and Wildlife Service on 22nd November 2017 where the broad outlines of the proposed compensatory measures were indicated by GHC.

The attached Report and supporting Appendices on the detailed proposals for "compensatory measures" are now being submitted for your consideration in advance of the tripartite meeting between ABP / NPWS / GHC scheduled for Monday 11th December 2017.

In support of this report we are also submitting a Screening Report prepared by AQUAFAC for your consideration.

It is envisaged that the Report on the proposed compensatory measures can be finalised following the tripartite meeting for early formal submission to ABP.
