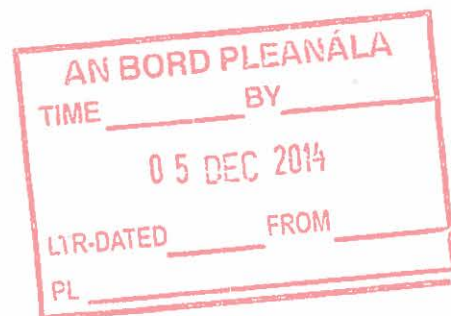
***Dear Mr Doherty,***
