My name is Colleen Melwani and I am 45 years of age. I have lived in the Stillorgan/Sandyford/Dundrum area my entire life. I currently reside in Sandyford with my two children. Based on the plans for the proposed development of Old Dundrum Shopping Centre, I submit this observation on the following grounds:

- 1) Blocks and Height – The proposed plans for 11 blocks ranging from 5 stories to 16 stories is totally out of character for the landscape of Dundrum.
- 2) Civic, cultural and community facilities – Currently already lacking in service for the population of Dundrum and the surrounding areas. There is no substantial provision set out in the plans for Dundrum to manage such facilities.
- 3) Traffic – Traffic congestion in Dundrum is already a cause of concern. A development this size, being 95% residential, will only exasperate the issue.
