Our main concern is the disproportionate scale of the planned development: the buildings planned at a height of (up to) 16 stories will provide housing but there seems to be no provision for quality housing, meaning relevant (and adequate) facilities, public services and sustainable buildings.

It feels like the plan is to build a huge development with no concern about Dundrum village, the community and residents (current and future).

Traffic and public transport is just one example that illustrates how unsustainable living in Dundrum it would become, if the planned development goes ahead: a trip on public transport during rush hour or a drive through the village is evident of that.

We certainly hope to make better use of the space provided in the Old Shopping Centre and would be very happy to include much needed housing, but we hope to make Dundrum a better place to live, not another over-crowded, under-serviced problem area in Dublin, where the only benefit is profit for developers.
