I would like to make a strong objection to the Hammerson / Allianz SHD plans for the Old Shopping Centre in Dundrum village.

The proposal includes 95% accommodation space and only 5% is given for commercial or services provision, which is a clear breach of zoning regulations.


Also the sheer scale, height, and visual impact of the scheme is spectacularly inappropriate for a small town, in an area where there are already multiple build to rent developments totalling over 8,000 units (in DLR area).

There is a need to develop the old Shopping Centre, but in a way that provides an improvement to village life and improves local amenity. This development has no benefit to the area whatsoever.

Finally I have to note that the architectural value of the development is extremely poor. This should be seen as an opportunity to build a true landmark building in keeping with the Luas bridge and older buildings like the Carnegie Library.

If this plan is approved it will destroy the village atmosphere, create huge public transport & parking issues, destroy visual amenity, and would represent a missed opportunity to truly create something special for Dundrum. The local residents deserve a better environment to live & work than this provides.
