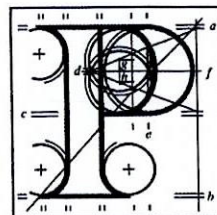

Dear Sirs,

On behalf of my client I acknowledge receipt of your letter dated 8.6.2023 and your invitation to make submission to the response made by the National Transport Authority to our objections dated 25.08.2022.

I note from their response that they are aware of our objections but have not addressed our concerns in any way. They have not indicated how my client is to service his business in the absence of any road frontage, loading bays or car parking. As pointed out in our original report the retention of the link road between Aughrim Street and Prussia Street and adjacent car parking will have absolutely no impact on the overall plan and will only impact on the proposal for the 'Stoneybatter Plaza'.

I emphasise once again that having a public plaza directly adjoining two late night venues such as a public house and a traditional 'Fish and Chipper' may not be a good idea. From my experience as an architect for over 40 years I have found that the main reason for Refusal of Planning for Take-Aways was that by their nature they encourage loitering leading to noise, disturbance litter etc particularly at night time.

I would ask you therefore on behalf of my client, at the very minimum to retain the link road and adjacent car parking and the existing arrangement which works very well. There will still be room for public plaza but at a distance from the public house and Take-Away.

My client and his parents have run a very successful business for many years and still live over the Take-Away. They are extremely concerned about the proposed development and would ask the Bord to address their concerns which are extremely genuine.
