Methods of describing soils and rocks

Soil and rock descriptions are based on the guidance in Section 6 of BS 5930: 1999, *The Code of Practice for Site Investigation*, with the following exceptions:

1. Where the strength of clay is based on field assessment without the availability of laboratory or in-situ test results the following terms are used, where applicable:
 - soft to firm: clay with undrained shear strength close to the BS5930 boundary (40kPa) between soft and firm soil.
 - firm to stiff: clay with undrained shear strength close to the BS5930 boundary (75kPa) between firm and stiff soil.
2. The relative density of coarse-grained soils, described in trial pit logs, is based on field observations including stability of pit sides and the ease/difficulty of excavation. The description is for indicative purposes only: as required by BS 5930, the relative density should only be determined by use of insitu tests, including standard penetration tests.

N5 Strategic Corridor Route Selection Site Investigation – Probes

1 AUTHORITY

On the instructions of the National Road Design Office Roscommon (NRDO), the Design Team, acting on behalf of the Client, Roscommon County Council, a Dynamic Probing investigation was carried out at specified locations to determine the depth of soft ground.

2 SCOPE

The extent of the investigation was as directed by the Engineer and included:

1. Dynamic Probing
2. preparation of a factual report

3 DESCRIPTION OF SITE

The scheme comprises the provision of approximately 34km of roadway for the N5 Strategic Corridor Scheme to upgrade the N5 National Primary Road between Tibohine and Scramoge.

4 SITE OPERATIONS

The Site Operations comprised:

- Dynamic Probing at 415 locations

The locations of the exploratory holes are shown on the exploratory hole location plan in Appendix A.

The number, location and depths of exploratory holes were as directed by the Engineer.

4.1 Dynamic Probes

A total of four hundred and fifteen dynamic probes were carried to ascertain the extent of the soft ground.

Dynamic probes were carried out using the DPSH method - Table 4 of BS5930 (British Standards Institute, 1999). The results are presented as counts and plots, against depth, of the number of blows per 100mm penetration. The plots are included in Appendix B.
