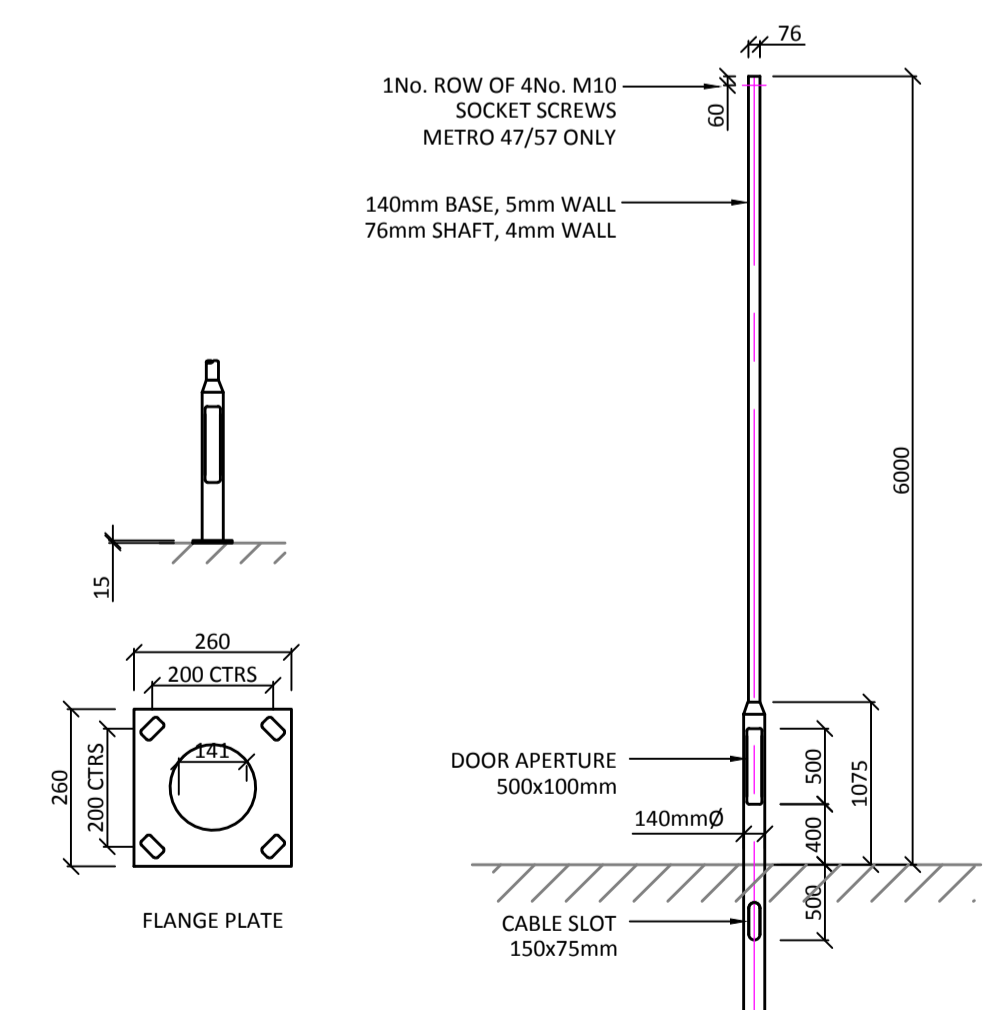

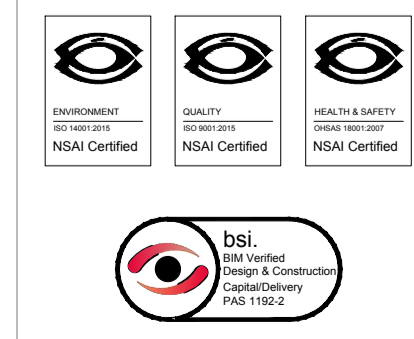


DETAIL No.1
