- A. Galway County Council, being the Planning Authority for the County of Galway (hereinafter referred to as "the Council") has become aware in relation to the development described in Schedule 1 hereto (the "Development") within the Council's administrative area for which the several Permissions set out in Schedule 2 were granted by the Council and/or An Bord Pleanála ("the Board") and for which an Environmental Impact Assessment ("EIA") was required and that a final judgment of the Court of Justice of the European Union in the case of Commission of the European Communities -v- Ireland (case C-215/06) has been made on the 3rd July 2008 that the permissions in Schedule 2, or certain of same, were in breach of law, invalid and/or otherwise defective for the reasons set out in the said Judgement and in particular were in breach of the provisions of European Directive 85/337/EEC (and as amended by European Directive 97/11) by reason of the omission from the application for permission of an Environmental Impact Statement in respect of those parts of the development for which permission was granted without an Environmental Impact Statement having been submitted as set forth in the Second Schedule hereto.
- B. You are the person who carried out the development and/or the owner and occupier of the land on which the development is situate.

## TAKE NOTICE as follows:

- 1. You are hereby informed of the proceedings referred to in Paragraph A above and the findings of same and a copy of the judgment in the said proceedings referred to in that paragraph (Case C- 215/06) is appended hereto.
- You are hereby directed to apply to the Board for substitute consent, within the meaning thereby assigned by the Planning and Development Act, 2000 as amended, in respect of the Development no later than 12 weeks from the date of this Notice.
- 3. You are directed to furnish with the application to the Board a Remedial Environmental Impact Assessment Report.
- 4. You should also ensure that the application complies with all relevant legislation (including the Planning and Development Acts, 2000 to 2019 and the Planning and

Development Regulations, 2001 to 2020 and may require a Remedial Natura Impact Statement to be furnished with the application.

# TAKE FURTHER NOTICE as follows:

- 5. You may make submissions or observations in writing to the Council no later than 4 weeks from the date of this Notice
- 6. Not later than 8 weeks from the date of this Notice, the Council shall:
  - (a) Where no submissions or observations are made to the Council, confirm or amend this Notice, or
  - (b) Where submissions or observations are made to the Council under Section 177B(2)(d), confirm, amend or withdraw this Notice.

177B.-(1) Where a planning authority becomes aware in relation to a development in its administrative area for which permission was granted by the planning authority or the Board, and for which—

- (a) an environmental impact assessment,
- (b) a determination in relation to whether an environmental impact assessment is required, or
- (c) an appropriate assessment,

was or is required, that a final judgment of a court of competent jurisdiction in the State or the Court of Justice of the European Union has been made that the permission was in breach of law, invalid or otherwise defective in a material respect because of—

- (i) any matter contained in or omitted from the application for permission including omission of an environmental impact statement or a Natura impact statement or both of those statements, as the case may be, or inadequacy of an environmental impact statement or a Natura impact statement or both of those statements, as the case may be, or

Further to receipt of a Notice from Galway County Council issued under Section 177B of the Planning and Development Act, 2000 (as amended) [attached as **Attachment 1**] Gort Windfarms Ltd. is are in the final stages of compiling the application documents in relation to a Substitute Consent application for the <u>Derrybrien Wind Farm Project in County Galway</u>. I will be acting as Agent for Gort Windfarms Limited on this application.

In advance of the submission, I wish to please confirm the following with the Board:

#### 1. Wording of the Public Notices

I attach a draft Site Notice and Newspaper Ad – **Attachments 2 and 3.** You will note I have left a space for a register reference number – pending clarification whether ABP will assigne a reference number for this file in advance of the submission being made.

Can you please confirm that the wording of the notices is to the satisfaction of the Board?

#### 2. Location of Site Notices

The application site extends over some 514 Ha. Significant parts of the site are remote from public roads. Furthermore there are a significant number of access routes to various parts of the site.

Given the extensive nature of the site, we have identified 17 No. locations where site notices may be required, identified on the attached map [Attachment 4]. In identifying this requirement, we note that - pursuant to Article 17(3) of the Planning and Development Regulations there is no requirement to erect a site notice for a development consisting of an overhead transmission line, but have taken a precautionary approach to ensure that the public are aware that this application is being made and erected notices at all reasonable locations.

Can you please confirm that this approach is to the satisfaction of the Board?

#### 3. Newspaper Ads

We propose to publish two newspaper ads - one in a National Newspaper (the Irish Independent) and one in a Regional Newspaper (Connacht Tribune), in compliance with the requirements under the Act and Regulations. These publication is approved by Galway County Council for planning ads in its functional area.

Can you please confirm this approach is to the satisfaction of the Board?

#### 4. Application Fee

The application fee has been calculated as follows, based on the inclusion of three classes of development:

On the basis of the above the application fee is €53,440.59.

However, per Paragraph 4, Section 3 of Schedule 9 'Maximum and minimum fees for planning applications', the maximum fee payable to a planning authority by an applicant in respect of any planning application other than an application mentioned in paragraph 1 (application for outline permission), 2 (application for or 3 (application for retention of unauthorised development) shall be €38,000.

Can the Board please confirm its calculation of the application fee as above and that the applicable fee is €38,000?

#### 5. Number of Copies of Documentation to be Submitted and Format of Same

The Substitute Consent application pack comprises 2 volumes of documents – Statutory application documents (including c.65 drawings) and Planning Report,
Environmental Documents – the rEIAR and rNIS. We propose to provide the Board with 6 No. (printed) hard copies of the application pack and 10 No. CDs containing the
files in a readable and searchable (PDF) format. Additional copies can, of course, be provided as required. It is noted that the applicant proposes to post the application
documents on a project website – www.derrybrienwindfarm.ie thereby ensuring it is available to members of the public.

Can the Board please confirm this is agreeable – or specify alternative number of copies for both hard and soft copies?

#### 6. Drawing Scales

In the context of the extensive site subject of this application, and having regard to the requirements of the Planning and Development Act, as amended and Regulations, we propose to submit drawings at the most meaningful scale possible. This will facilitate the review of the application pack for all readers.

Having regard the to the provision under the Regulations where an Applicant may agree alternative scales for drawings with the Planning Authority, prior to the submission of the application, agreement on the following is requested:

- Site Location Map the typical requirement is for a site location map not less than 1:1,000 in a built-up area and 1:2,500 in all other areas. For ease of site identification and inspection whereby the entire site can be seen in context, a 'Strategic Site Location Map, is provided at 1:50,000 (to facilitate site identification) 1:15,000 and 1:10,000 with varying levels of detail. Collectively these drawings will provide all information required under the Regulations including details such as distances of structures from boundaries. More detailed site location / layout maps at 1:2,500 are then provided noting that there are 17 such sheets required to cover the entire site.
- Other Plans, Elevations and Sections The planning pack comprises drawings of existing structures. Given the large-scale of many of the these features, these are shown at the most relevant scales typically at 1:500 and 1:200, though there may be a deviation from the standard where necessary to capture and display all details.

In addition to scaled drawings we propose to print two copies of the drawings within an A3 folder. We propose clearly label that these drawings are not to scale, noting that they are provided for ease of review.

A similar approach will be taken to the Figures set out in the EIAR – which will be printed at A4 within the body of the documents with a separate folder containing all at A3 – again for the ease of review.

Can you please confirm that this approach is to the satisfaction of the Board?

7. **Timeframe for Submission** - You will note that an initial notice was issued by Galway County Council on 9<sup>th</sup> June and that notice was confirmed on 23<sup>rd</sup> July. The Notice requires Gort Windfarm Limited to submit an application to An Bord Pleanála within 12 weeks i.e. by 31<sup>st</sup> August 2020. As permitted under S.177E(4) of the Act, Gort Windfarms Ltd. requests that the Board extends this deadline by <u>a further 2 weeks i.e. until 14<sup>th</sup> September 2020</u>, to facilitate this substantial submission within a reasonable timeframe.


