

Thank you for your letter/scoping report and request for comments in relation to the proposed Barnadivane Wind Farm to be located in the townlands of Lackareagh, Garranereagh and Barnadivane (Kneeves), near Teerelton, Co. Cork.

The development appears to be approximately 32km West of Cork Airport, as such, it is recommended that the developer engage directly with Cork airport (including IAA-ANSP and Engineering) to make them aware of the proposal and ensure appropriate screening from an aviation safety perspective.

It is likely that the following general observations would be proffered by the Authority during a formal planning process: In the event of planning consent being granted, the applicant should be conditioned to contact the Irish Aviation Authority to:

- (1) agree an aeronautical obstacle warning light scheme for the wind farm development,
- (2) provide as-constructed coordinates in WGS84 format together with ground and blade tip height elevations at each wind turbine location

Dear Sinead.

Thank you for the email and the detail contained in the attached.

The nearest turbine is at c.17nm from Cork Airport and does along with the other proposed turbines fall within the airspace where the IAA ANSP has responsibility for safeguarding of Instrument Flight Procedures (IFPs) for Cork Airport.

In order to make initial assessments of potential impacts we use a Safeguarding Grid to see if the proposed development will penetrate the IFPs surfaces.

With the proposed tip height of 131m on a site with an elevation of 265m (in the highest turbine site) = total elevation 366m AMSL. The safeguarding elevation we apply for this area is 583m AMSL, so the proposed turbines are well below this value and therefore not of concern to us.

I should note that from a Regulatory perspective, these turbines will need to be notified to <u>airspace@iaa.ie</u> as they are obstacles greater than 100m elevation.

Interested parties from daa Cork Airport are copied for information.

I refer to your letter of the 29<sup>th</sup> September in regard to the consultation regarding Barnadiyane Wind Farm.

The Irish Aviation Authority (IAA) Air Navigation Services Division (ANSD) does not get involved in the planning process. The IAA ANSD is to be notified as detailed hereafter:

According to <u>S.I. 215 of 2005</u>, Irish Aviation Authority (Obstacles to Aircraft in Flight), the IAA ANSD requires any person who seeks to erect a manmade object to notify the aerodrome operator of the intended operation <u>at least thirty days</u> in advance if the structure is to be erected in the vicinity of the aerodrome or the areas around the aerodrome and other protected surfaces associated with the aerodrome. Aerodrome Operators can be contacted via <u>IAA AIP AD 1.3 INDEX TO AERODROMES AND HELIPORTS</u>, to evaluate the impact of the intended operation on the protected airspace established for the aerodrome.

Additionally, any person who seeks to erect a manmade object in excess of 45 metres anywhere within the state above ground or water surface level must also notify the IAA ANSD of the intended crane erection at least thirty days in advance, as a crane operating at or above this height may constitute an obstacle to air navigation. The IAA ANSD can be contacted via airspace@iaa.ie.
