Re: Letter of consent regarding the Planning Application by Drumnahough Wind Farm DAC for the Drumnahough Wind Farm as it relates to Coillte property in Co. Donegal

Dear Sirs,


Coillte Cuideachta Ghníomhaíochta Ainmnithe (“Coillte CGA”) is the owner or the party entitled to be registered as owner of the properties known as Cark, Drumnahough, Treankeel, Carrickalangan, Tooslenagh, Lenalea, Killymasny and Kirkneedy, County Donegal which are outlined in black on the indicative map (“Map 1”) attached hereto (hereinafter called “the Property”).

Please note that I have no authority to bind Coillte and no binding agreement shall exist or be deemed to exist until such a time as a formal contract has been agreed between all parties, executed and exchanged and all sums due there-under paid in full. Please note that this letter is not and shall not constitute a note or memorandum in writing for the purposes of Section 51 of the Land and Conveyancing Law Reform Act, 2009.

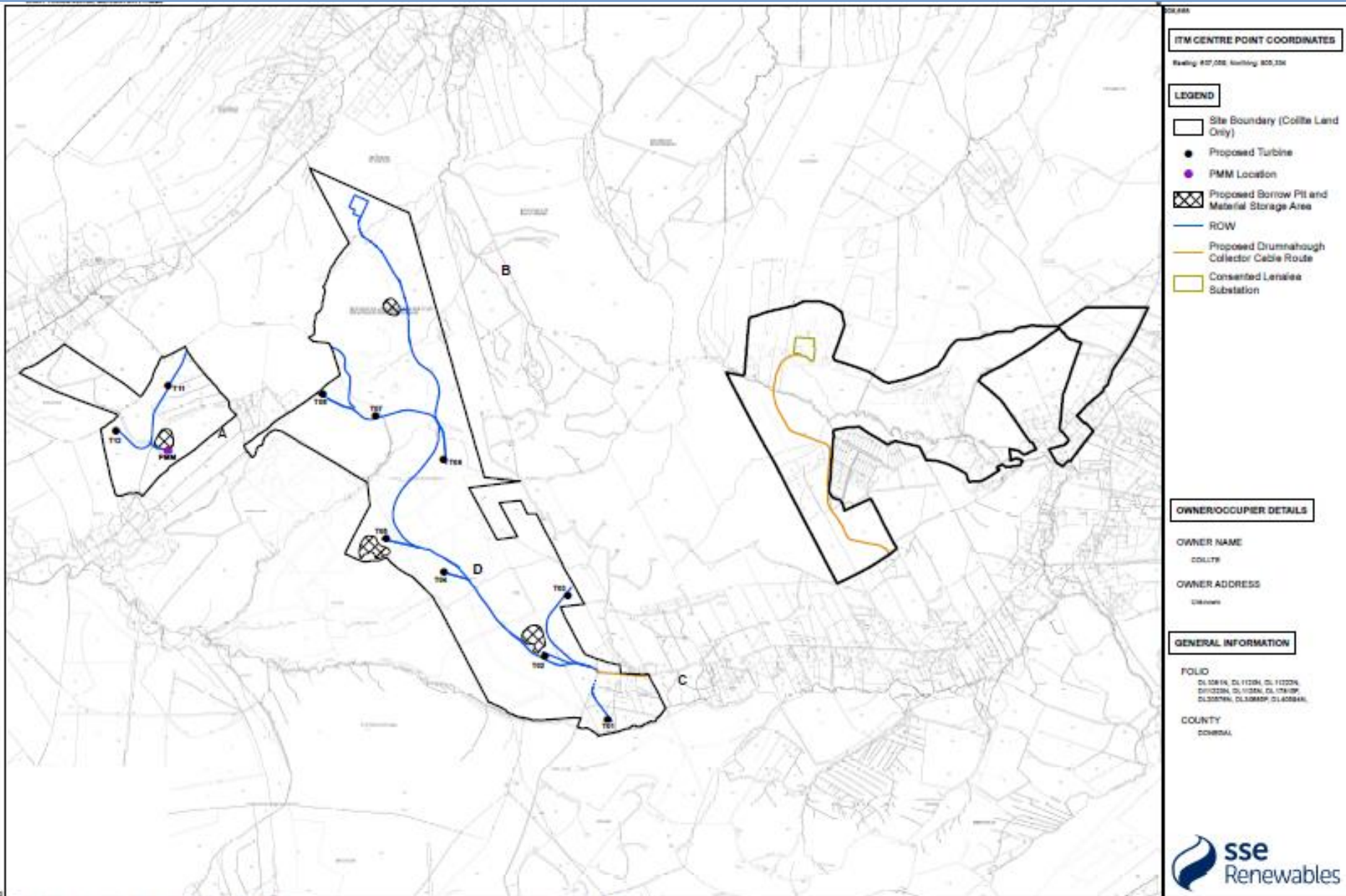
