# 25. Summary of Residual Impacts

#### 25.1 Introduction

This Addendum Chapter summarises the additional residual impacts resulting from the updated assessment carried out for this Environmental Impact Assessment Report (EIAR) Addendum (marked as 'New'), and any amended impacts to those identified in Chapter 25 (Summary of Residual Impacts) in Volume 3 Part A of the EIAR in the 2018 planning application (marked as 'Amendment to the EIAR in the 2018 planning application'), which will result from the Construction Phase and Operational Phase of the Greater Dublin Drainage Project (hereafter referred to as the Proposed Project), as identified as part of the Addendum assessment.

For full Addendum impact assessments, please refer to Chapter 6A to Chapter 21A in Volume 3A Part A of this EIAR Addendum. Residual impacts are the final or intended impacts which occur after the proposed mitigation measures have been implemented. They refer to the degree of change that will occur after the proposed mitigation measures have taken effect. All other (Not Significant or Imperceptible) impacts are detailed within Chapter 6A to Chapter 21A in Volume 3A Part A of this EIAR Addendum.

Table 25.1 presents the residual impact significance following implementation of mitigation, as summarised in Chapter 24 (Summary of Mitigation Measures) in Volume 3A Part A of the EIAR in the 2018 planning application, as supplemented by Chapter 24A (Summary of Mitigation Measures) in Volume 3A Part A of the EIAR Addendum. The additional residual impacts presented in this Addendum Chapter are adverse unless otherwise stated as positive / beneficial. The terminology used in this Addendum Chapter to describe the residual impact significance is a reflection of the assessment terminology and guidelines used within Chapter 6A to Chapter 21A. While the terminology in the Environmental Protection Agency (EPA) Guidelines on the Information to be Contained in Environmental Impact Assessment Reports (EPA 2022) is predominantly used, some Addendum chapters use discipline specific guidelines, and this terminology is presented within this summary chapter to maintain consistency with the assessments of Chapter 6A to Chapter 21A.

This Chapter should be read in conjunction with Chapter 25 (Summary of Residual Impacts) in Volume 3 Part A of the EIAR in the 2018 planning application. Please note that Section 18A in Volume 4A Part A of this EIAR Addendum discusses residual impacts in relation to the proposed Regional Biosolids Storage Facility (RBSF) element of the Proposed Project.
