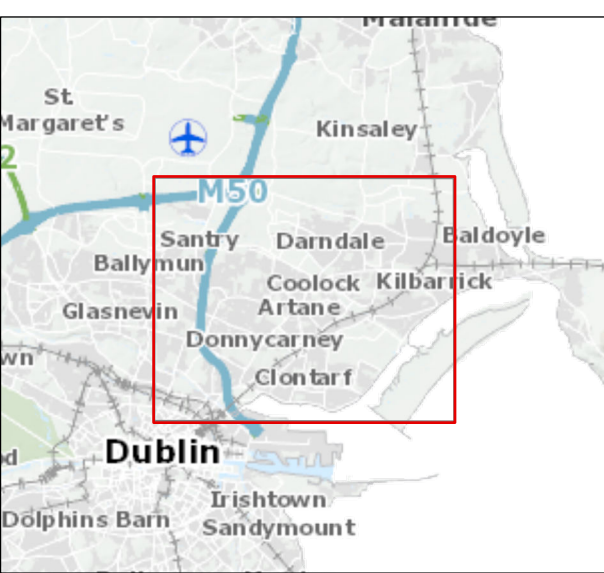
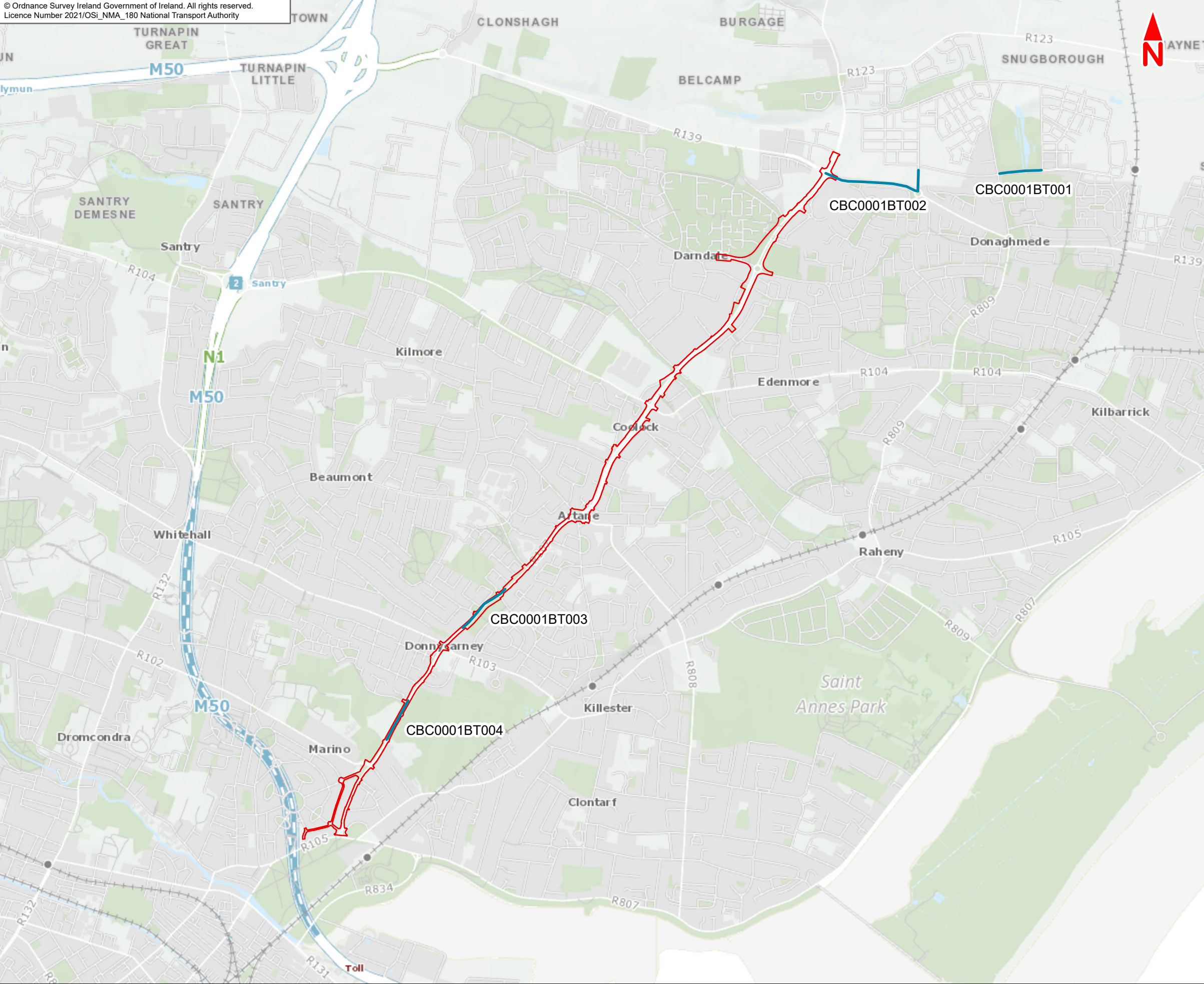

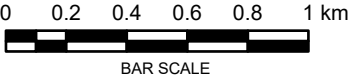
### Ecological Study Areas: Bat Activity Transect Routes

### Ecological Study Areas: Wintering Bird Survey Sites



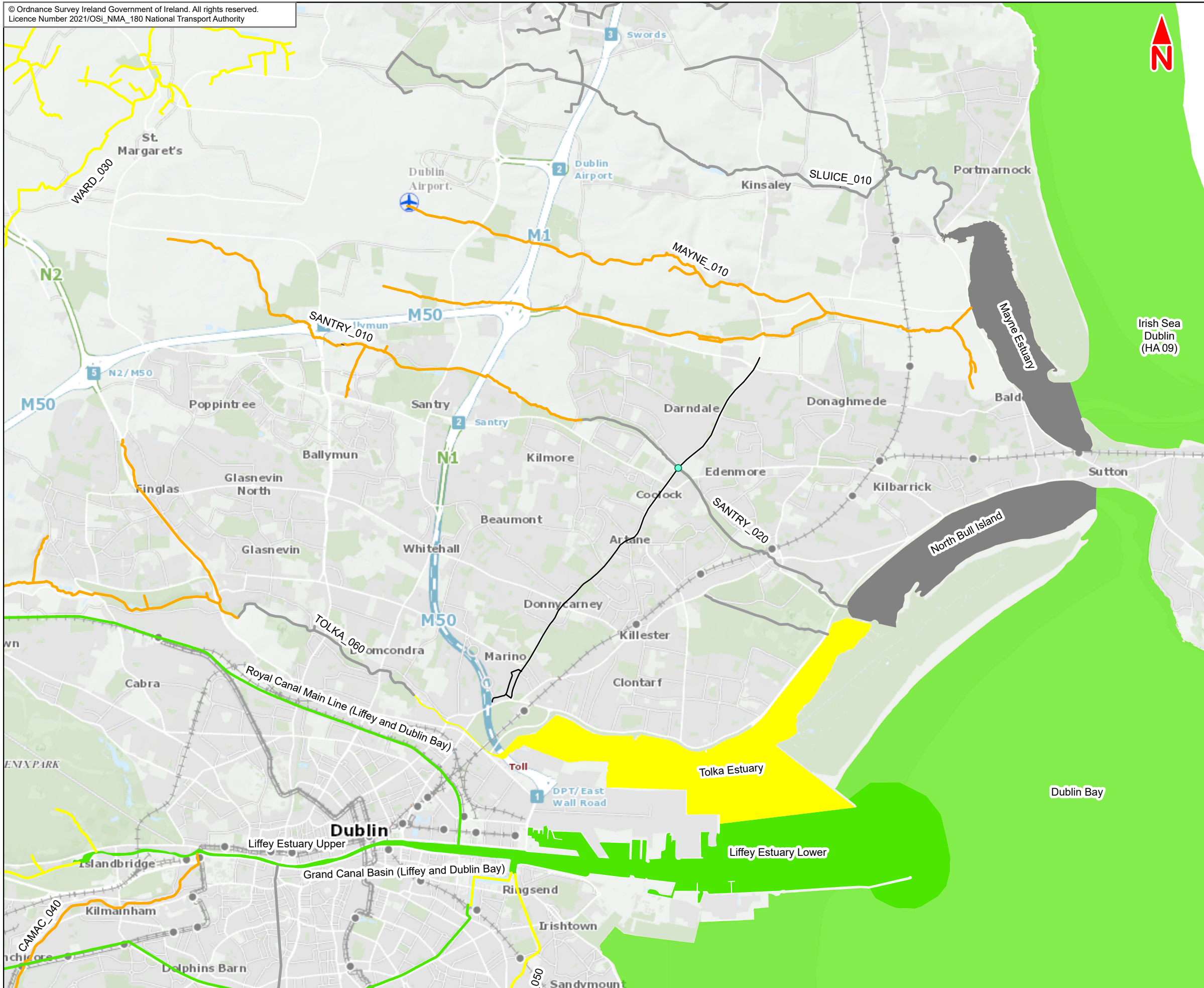

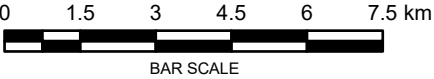
### European Sites in the Vicinity of the Proposed Scheme

### Natural Heritage Areas and the Proposed Natural Heritage Areas in the Vicinity of the Proposed Scheme



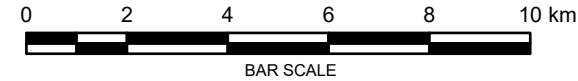
