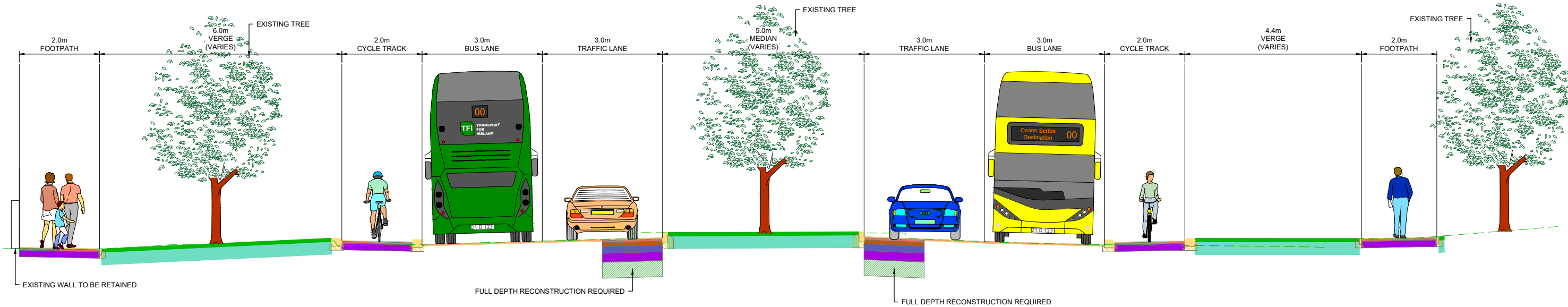

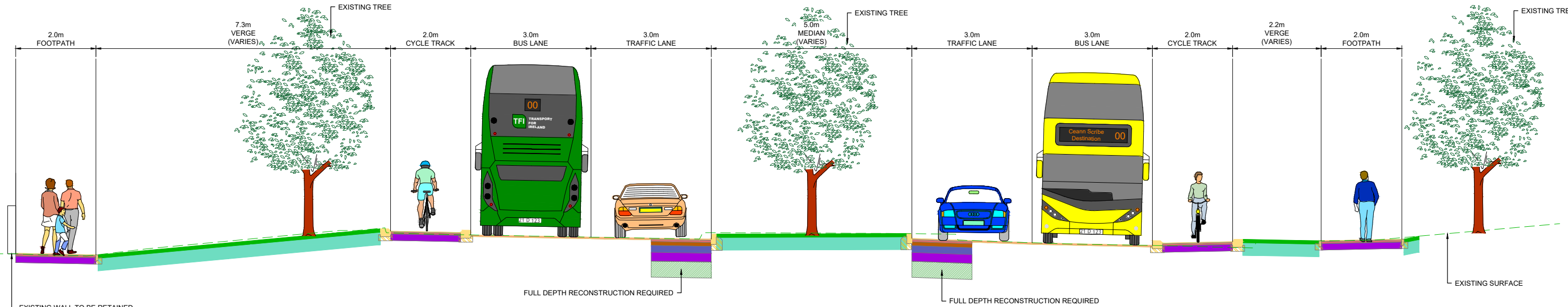

MALAHIDE ROAD





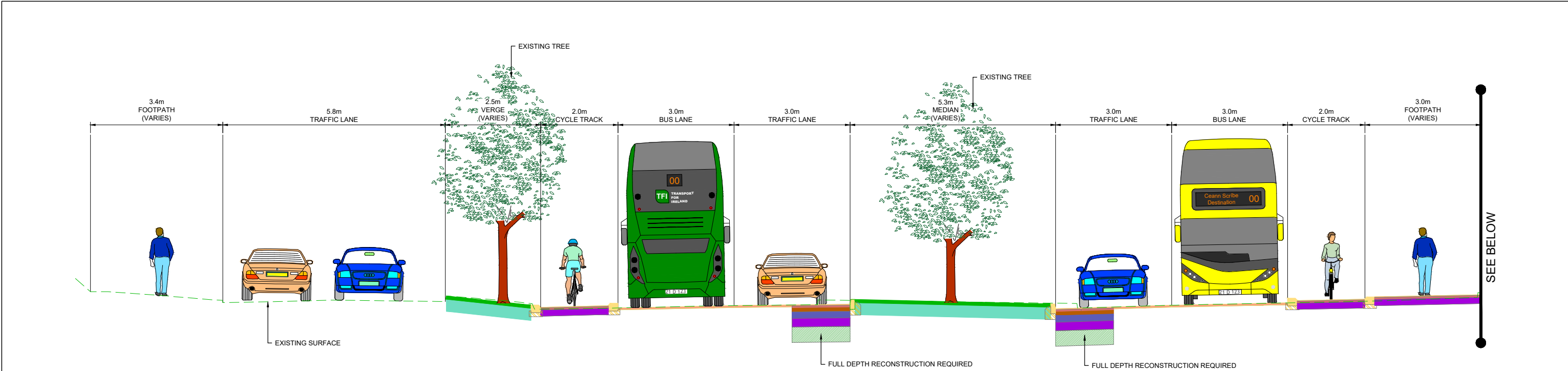
TYPICAL SECTION D-D

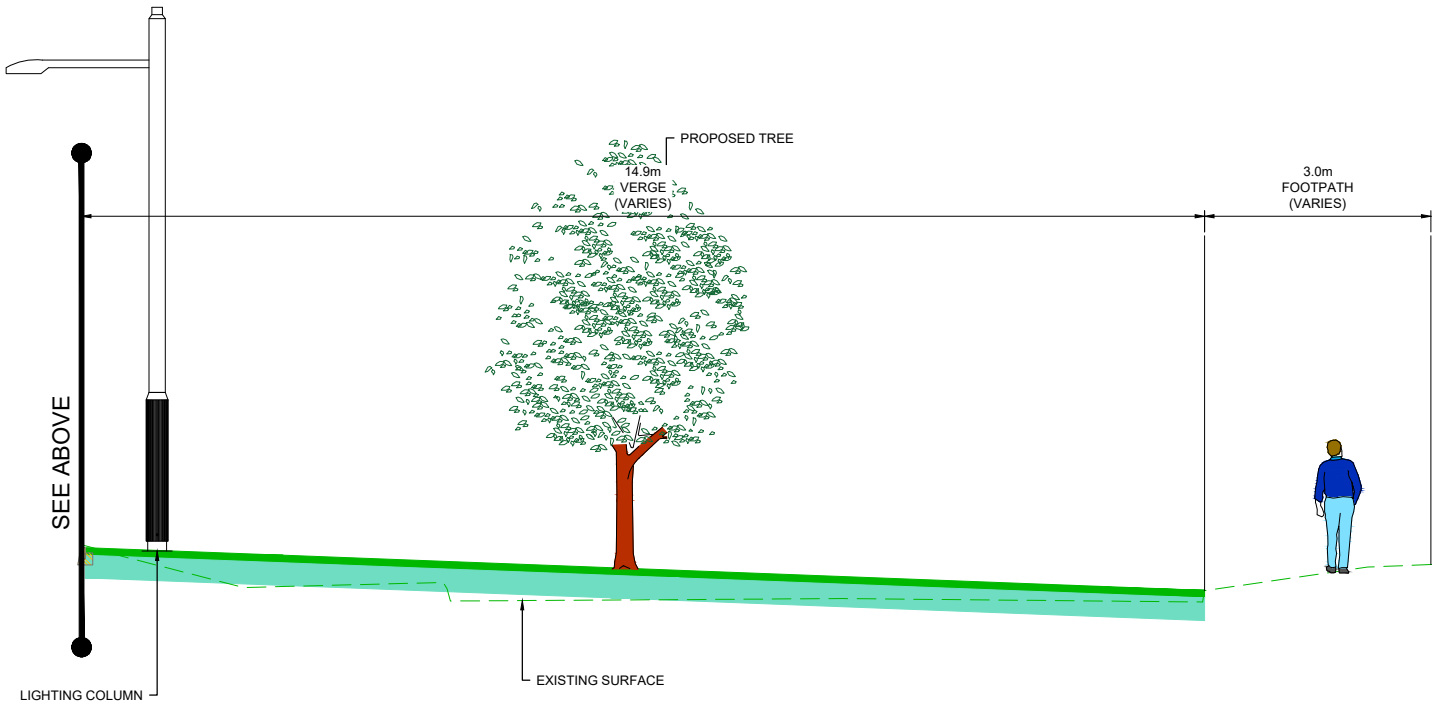

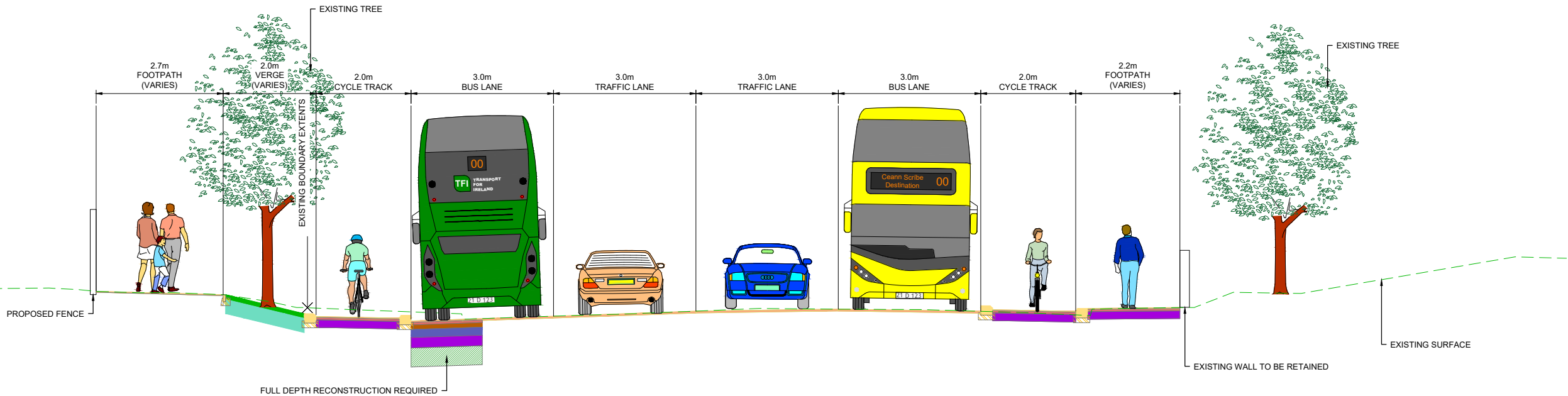

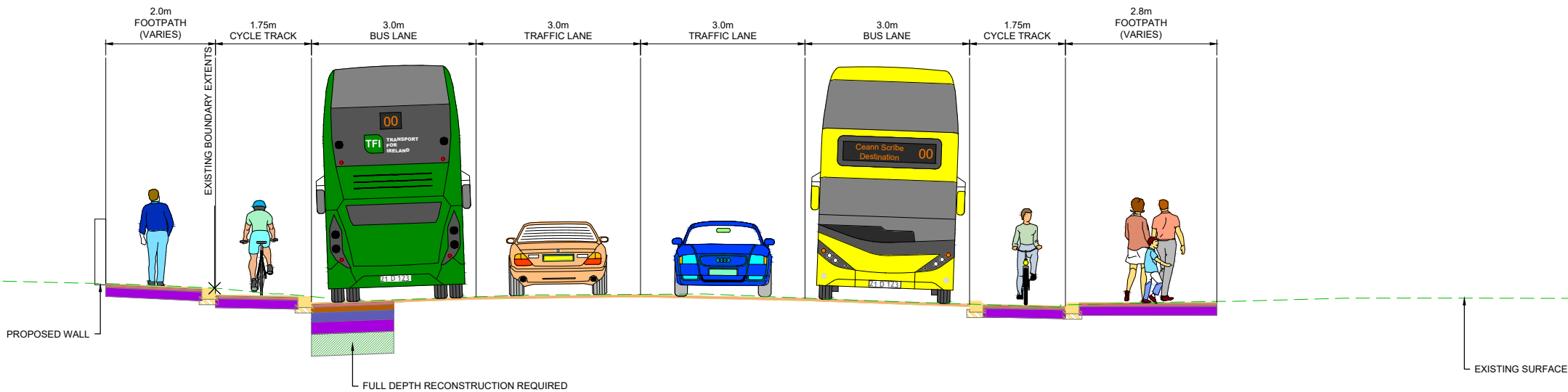
