I believe an oral hearing should take place on this SHD due to the conflicting nature of the site as previously outlined in other Bord Pleanala rulings for development on this land. Legislation underlining these types of land remain to be decided by the Oireachtas. Every application on this site is one that is fraught with emotions and deserve oral hearings to allow for a full picture of the development concerned.

As referenced in the Fifth Interim Report of the Mother and Baby Homes Commission, published on 17th April 2019: The Commission considers that it is likely that some of the children are buried in the grounds but has been unable to find any physical or documentary evidence of this. In particular, during the 1940s (when many of the deaths occurred) and when petrol was scarce, it would have been very expensive to arrange off-site burials. However, as no physical evidence of possible locations was found, the Commission did not consider it feasible to excavate 60 acres not to mention the rest of the former 200 acre estate. If the Bord today to grant planning, a condition of a full geophysical examination the Bessborough site, in totality, must be a condition of planning. That is the only way to know for sure what lies beneath Bessborough but an oral hearing should take place.

I have serious concerns on transport access to and from Bessborough with one road in and one road out and the impact this development will have on residents with no further access being discussed.
