maidir le tógáil na Scéime Croíchonair Bus ó Bhaile Bhlainséir go Lár na Cathrach, ar scéim í atá thart ar 10.9 km ar fad ar an iomlán, tosaíonn sí ag slíosbhóthar Acomhal 3 (Baile Bhlainséir/Mullach Eadrad) ó dheas ón N3 agus leanann sí ar aghaidh feadh Bhóthar Bhaile Bhlainséir Theas/an R121 isteach in Ionad Siopadóireachta Bhaile Bhlainséir. Ó láthair ceann turais nua siar ó thuaidh ó Ionad Siopadóireachta Bhaile Bhlainséir, leanann an Scéim bealach isteach ar Bhóthar na hUaimhe/an N3 trí acomhal Bhóthar Snugborough, agus leanann sí an N3 agus Bóthar na hUaimhe chomh fada leis an acomhal le Seanbhóthar na Cabraí, agus leanann sí bealach ansin feadh Sheanbhóthar na Cabraí, Shráid na Prúise, Shráid an Mhainéir agus Bhóthar na gCloch go dtí an t-acomhal le Sráid an Rí Thuaidh. Leanann an Chroíchonair Bus bealach ansin feadh Phlás Blackhall chomh fada leis an acomhal le Cé Ellis/Cé Árann, a bhfuil gach ceann diobh ionnaithe i gContae Bhaile Átha Cliath agus laistigh de limistéar riarracháin Chomhairle Cathrach Bhaile Átha Cliath nó de limistéar riarracháin Chomhairle Contae Fhine Gall, a bhfuil na nithe seo a leanas, i measc nithe eile, i gceist leo:

- 21.2 km (déthreo) de bhonneagar tosaiochta bus agus de bhainistíochta tráchta;
- 17.1 km (san iomlán sa dá threo) de bhonneagar rothaiochta agus de shaoráidí rothaiochta;
- Saoráidí nua/athchóirithe do choisithe agus cosáin nua/athchóirithe a sholáthar feadh na scéime, agus oibreacha coimhdeacha gaolmhara a sholáthar;

NOTICE OF A FURTHER PERIOD OF TIME FOR THE MAKING OF SUBMISSIONS RELATING TO THE BLANCHARDSTOWN TO CITY CENTRE CORE BUS CORRIDOR SCHEME PURSUANT TO 51(3) OF THE ROADS ACT 1993 (AS AMENDED)

BLANCHARDSTOWN TO CITY CENTRE CORE BUS CORRIDOR SCHEME

Further to the Notice published on 30 June 2022 pursuant to Section 51(3)(a) of the Road Act 1993 (as amended) in relation to the Blanchardstown to City Centre Core Bus Corridor Scheme advising that the National Transport Authority (NTA) had applied under section 51(2) of the Roads Act 1993 (as amended) to An Bord Pleanála ('the Board') for approval in relation to a proposed road development consisting of:

The construction of Blanchardstown to City Centre Core Bus Corridor Scheme which has an overall length of approximately 10.9km, and commences at Junction 3 (Blanchardstown/Mulhuddart) southbound off-slip from the N3 and proceeds along the R121 Blanchardstown Road South into the Blanchardstown Shopping Centre. From a new terminus to the north-west of Blanchardstown Shopping Centre, the Scheme is routed onto the N3 Navan Road via Snugborough Road junction and follows the N3 and Navan Road as far as the junction with the Old Cabra Road, then routed along the Old Cabra Road, Prussia Street, Manor Street and Stoneybatter to the junction with King Street North. The Core Bus Corridor is then routed via Blackhall Place as far as the junction with Ellis Quay/Arran Quay, all in the County of Dublin and within the Dublin City Council (DCC) and Fingal County Council (FCC) administrative areas, comprising inter alia:

- 21.2km (two-way) of bus priority infrastructure and traffic management;
- 17.1km (total both directions) of cycling infrastructure and facilities;
- Provision of new/refurbished pedestrian facilities and footpaths along the scheme and associated ancillary works;
- Provision of 41 junction upgrades and associated ancillary works;
- Provision of 32 new/refurbished raised table side entry facilities;
- Reconfiguration of existing bus stops resulting in 57 number new bus stop facilities;
- Provision of a new Bus Interchange consisting of 6 boarding bays and 6 drop-off bays;
- Public Realm works including landscaping, planting, street furniture, street lighting, retaining walls, boundary walls and sustainable urban drainage (SUDs) measures;
- Roads associated earthworks including excavation of unacceptable material, importation of material, temporary storage of materials;
- Provision of road pavement, signing, lining and ancillary works;
- Provision of gates, fencing and boundary treatment works;
- Provision of new and diverted drainage infrastructure;
- Diversion of utilities and services including associated ancillary works; and
- Construction of accommodation works including boundary treatment and ancillary grading and landscaping works; together with all ancillary and consequential works associated therewith.

A further period of time is being provided for:

- the inspection of the application documentation, Environmental Impact Assessment Report and the Natura Impact Statement;
 - the purchase of a copy of the Environmental Impact Assessment Report (or part(s) thereof) and/or the Natura Impact Statement; and,
 - the making of submissions/observations,
- from 8th September 2022 to 3rd November 2022.

The location of the proposed road development is illustrated in the accompanying map. As stated in the notice published on 30 June 2022, the NTA has submitted to the Board an Environmental Impact Assessment Report in respect of the proposed road development and a Natura Impact Statement has also been submitted to the Board.

This further period of time for inspection and for the making of submissions/observations is being provided so as to ensure full and effective public participation as it has come to the National Transport Authority's attention that due to an administrative error Figures 6.1 to 6.12 in Volume 3 of the Environmental Impact Assessment Report were not available for inspection on the NTA website for the Blanchardstown to City Centre Core Bus Corridor Scheme during the previous period for inspection and for the making of submissions/observations that ended on 30 August 2022 (although these figures were available for inspection at (i) the offices of the NTA, (ii) the offices of An Bord Pleanála and (iii) on the website of An Bord Pleanála at <https://www.bleanala.ie/en-ie/case/313892>). This error has now been rectified on the NTA website for the Blanchardstown to City Centre Core Bus Corridor Scheme (www.blanchardtownscheme.ie).

Therefore, submissions/observations may be made in writing to **An Bord Pleanála (Strategic Infrastructure Division), 64 Marlborough Street, Dublin 1, D01 V902** in relation to:

- the likely effects on the environment of the proposed road development if carried out;
- the implications of the proposed road development, if carried out, for proper planning and sustainable development in the area in which it is proposed to situate the proposed road development; and
- the likely significant effects of the proposed road development on a European site

so as to reach the said Board **not later than 5:30pm on 3rd November 2022.**

Any submissions/observations must be accompanied by a fee of €50. As with the previous Notice, this fee will not apply to certain prescribed bodies including those specified in section 51(3)(b) of the Roads Act 1993 (as amended) or to landowners and others with a legal interest in land which is the subject of the Blanchardstown to City Centre Core Bus Corridor Compulsory Purchase Order 2022.
