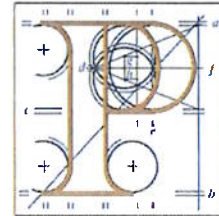

Dear Sir / Madam,

An Bord Pleanála has received your letter in which you intended to make an appeal under the Planning and Development Acts, 2000, (as amended).

Section 127(1)(f) of the 2000 Act, (as amended), provides that an appeal shall be accompanied by the statutory fee. 

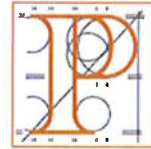
