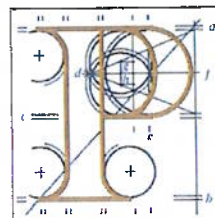

An Bord Pleanála has received your letter in which you intended to make an appeal under the Planning and Development Acts, 2000, (as amended).

Section 127(1)(f) of the 2000 Act, (as amended), provides that an appeal shall be accompanied by the statutory fee. Your letter was not accompanied by the fee as stipulated in the Board's order of 14th February, 2011 and as provided for under section 144 of the 2000 Act, (as amended), and it is regretted that it must, therefore, be regarded as an invalid appeal in accordance with section 127(2)(a) of the Act. The fee required in your case is €220. You are reminded that the final date for the lodgement of a valid appeal is 4 weeks beginning on the day of the decision of the planning authority. In this case, the time period to lodge a valid appeal has expired.


Please note, the Board has received a valid appeal in relation to the above planning application. The last day for the submission of observations falls on the 26th July, 2022.

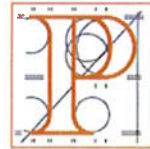
