Re. Stephen Little Submission - Comments

The Local Area Plan.

An Bord Pleanála must not make any decision on this application until a Local Area Plan (LAP) is drawn up for this historic area as required under The Dublin Development Plan. The applicants offer no evidence whatsoever to show that 'the Planning authority are of the view that permission can be granted in the absence of the LAP. If that is the case the Authority would be acting contrary to its own development plan for the capital city.

Listed Buildings.

The applicant's plan shows a disregard for the vote taken by Councillors to add historic buildings in particular the terrace of buildings from 10 to 25 Moore Street - all of which contain elements or features as well as the footprint of the original structures - to the list of protected structures. The intention of the elected representatives to protect and preserve the buildings is ignored and reduced to the preservation of parts of buildings in a cherry picking exercise in an area that satisfies the criteria laid down by the High Court and Court of appeal for protection as a National Monument.

The Mola Drawings show an unacceptable level of demolition along Henry Place and a redrawing of the intersection with Moore Lane where volunteers fell under enemy machine gunfire.

The plan to superimpose an eight storey hotel atop a wall of the O'Brien Water Works building is not conservation - it is nothing more than a nudge and wink approach to historic preservation and should be rejected by An Bord.

The Moore Street Advisory Group

The Hammerson Plan does not meet the agreed recommendations of the Advisory group to the Minister in Securing History 1 - a report agreed by ALL participants.

Recommendations/Objectives

The submission shows that The Hammerson Plan fails to meet the recommendations of the City Council Advisory Group chaired by Cllr Nial Ring.

The submission shows The Hammerson Plan fails to meet the recommendations of The Lord Mayor Forum under the tenure of six Lord Mayors.

The submission shows The Hammerson Plan fails to meet the objectives of the Venice Charter and other international Guidelines on preservation of history and heritage.

Pre 1916 Buildings

The terrace of buildings at 10 to 25 is worthy of preservation as a result of its place in history. Where necessary modern in fill buildings along the terrace can be replaced and NOT removed as 'non original' to facilitate the commercial interest of the applicants. The GPO itself is not original having been destroyed by incendiary shellfire in 1916 - Only a buffoon would suggest it can be demolished on the basis that it is not 'original'.

In Conclusion

It is our view that An Bord should make no decision on the Hammerson Planning applications until such time as the allegations of interference with the planning process in relation to proposed payments to Moore Street traders and highlighted in the Dail by deputy Aengus O Snodaigh TD are fully investigated.
