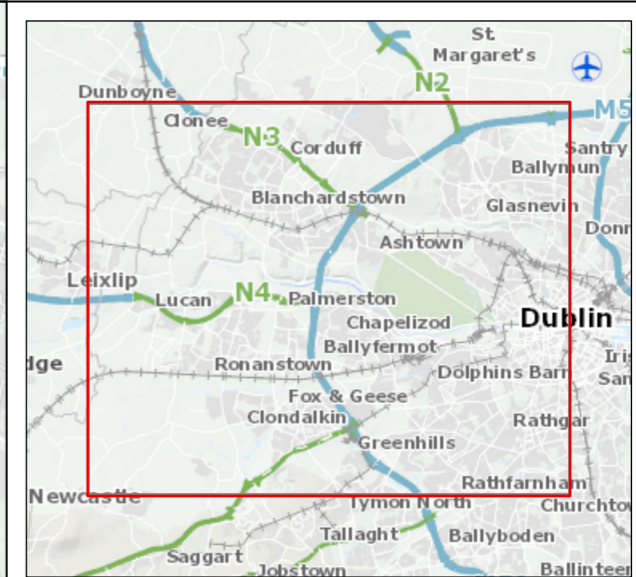
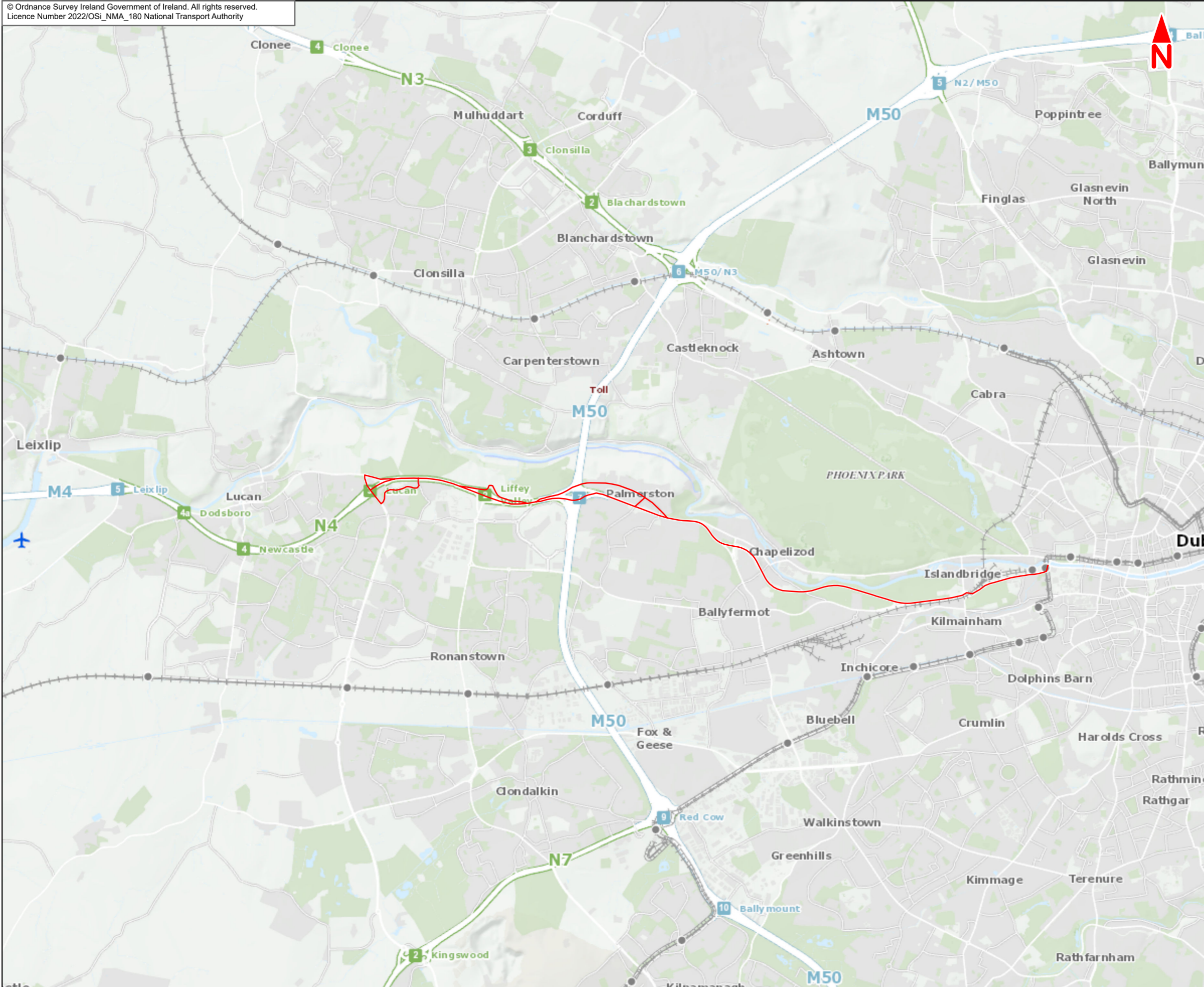

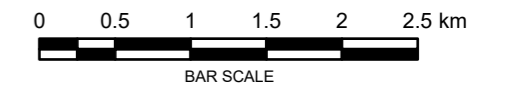


**Figure 1A**

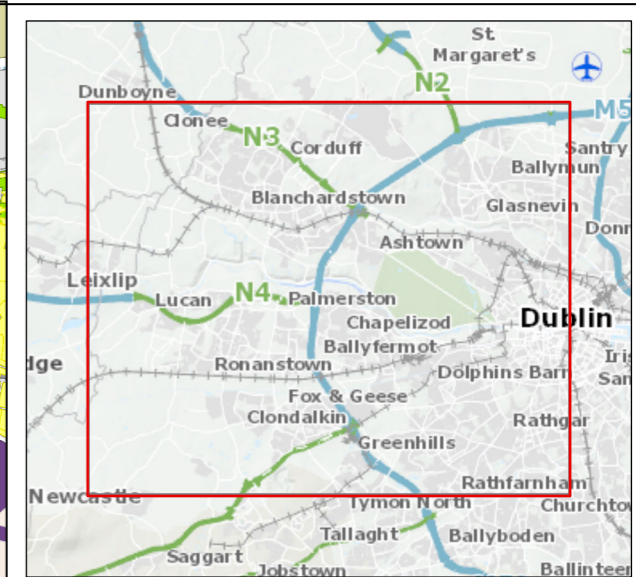
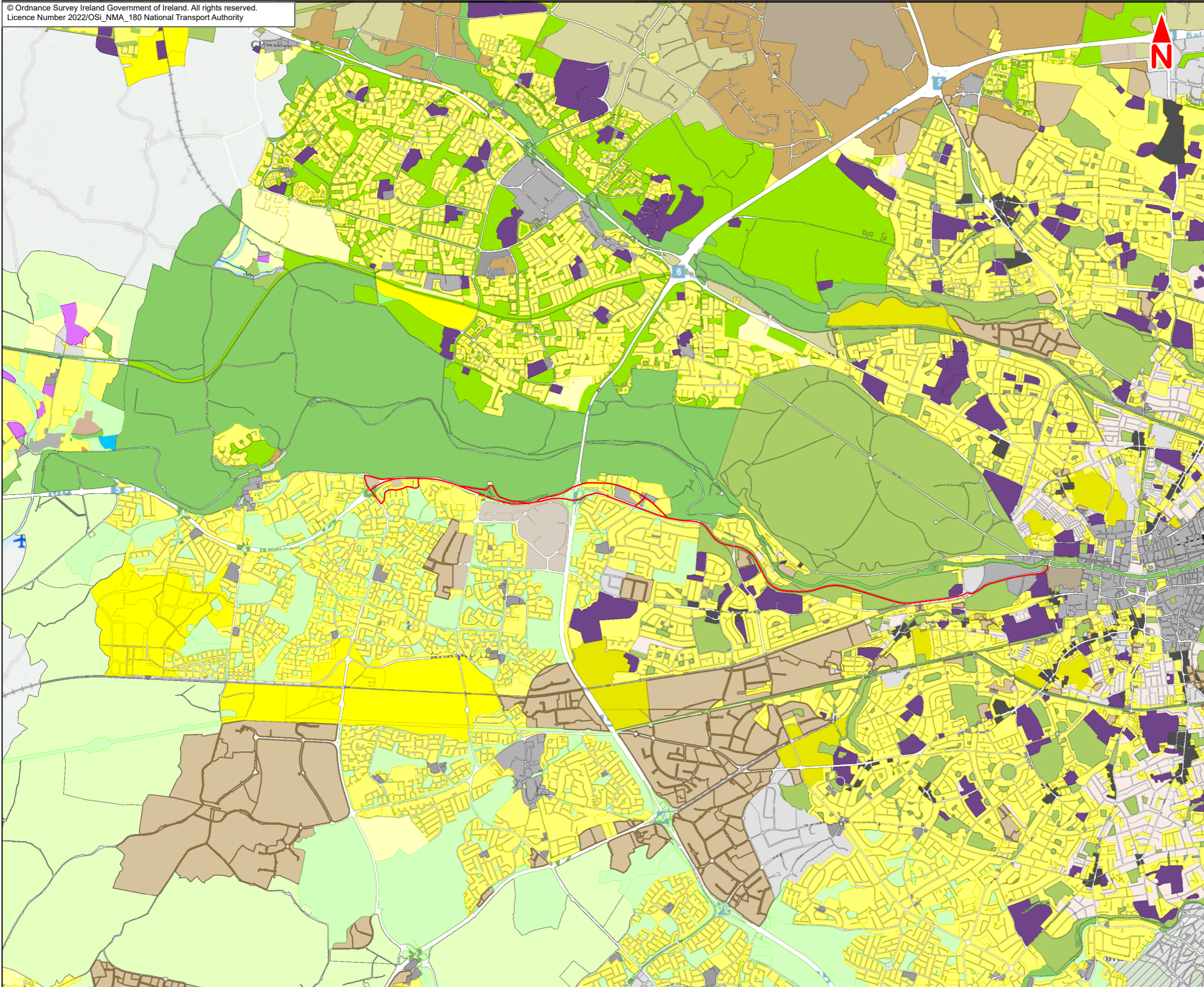

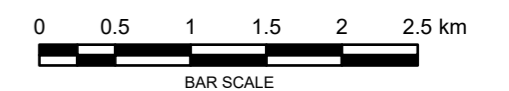


**Figure 1B**

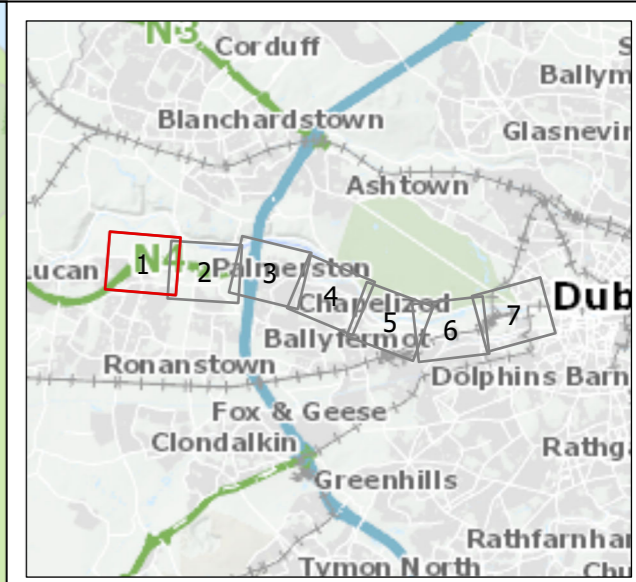

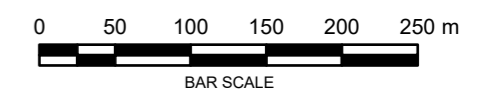
**Figure 1C**

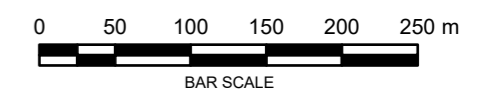
**Figure 1G**

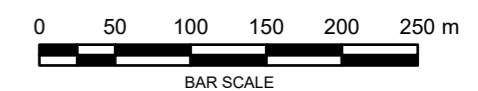
**Figure 11**
