Summary of the Bill:
1. The Bill increases the RHA of the
view that there is a growing
population of younger artists in Ireland,
and it is desirable to increase the
membership of the Royal Hibernian
Academy (RHA). The Bill is designed
to increase the membership of the
RHA and to remove some of the
outdated provisions of the Charter
which are no longer relevant.
2. The Bill has 6 main features:-
a. The Bill increases the RHA's
membership from 30 to 55;
b. The Bill creates a new permanent
position of 'Keeper' in addition to
President and Secretary;
c. The position of Keeper is provided
for in the RHA's bye-laws and is
the person having the care of the RHA's
works of art or property confined to
its care;
d. The Bill removes the limit of a yearly
value of one thousand pounds on
the value of assets which may be
purchased by or given to the RHA;
e. The Bill replaces the qualifying
profession of engravers with the
profession of printmakers;
f. The Bill removes the geographic
limit on the holding of meetings
within the City of Dublin or ten
miles thereof;
g. The Bill replaces the quorum in the
event of the absence of the President
for the purpose of electing a vice
president from nine or more members
to one third or more members.
