

I am writing to appeal the most recent decision by Donegal County Council to grant permission to Patrick Bonar in an application for:

(1) DEMOLITION OF EXISTING CONCRETE STRUCTURE (2) QUARRYING OF 5.37 HECTARES WHICH WILL BE SUBJECT TO EXTRACTION AND PROCESSING OF ROCK THROUGH DRILLING, BLASTING, CRUSHING AND SCREENING (3) CONSTRUCTION OF (A) SETTLEMENT PONDS AND WETLAND (B) A SHED FOR THE PURPOSES OF STORAGE FOR THE FACILITY INCLUDING ON-SITE MACHINERY MAINTENANCE (C) SITE OFFICE WITH CANTEEN, TOILET & DRYING FACILITIES (4) INSTALLATION OF A WASTEWATER TREATMENT SYSTEM & PERCOLATION AREA (5) PROVISION OF A WHEEL WASH AND WEIGHBRIDGE (5) LANDSCAPING OF THE QUARRY DURING THE OPERATIONAL PHASE AND RESTORATION OF THE QUARRY ON COMPLETION OF EXTRACTION (5) ALL ASSOCIATED ANCILLARY FACILITIES / WORKS OVER A 25 YEAR PERIOD.

My reasons for appealing this decision are as follows:

- 1. The priority for Raphoe's resource use should be given to amenities focused on the natural environment, history, and archeology, as Raphoe is a designated Heritage town situated in an area of natural beauty. These will be severely compromised if the proposed quarry development were to proceed. The specialness of this area is characterised by the Beltany Stone Circle, the Tullydonnell hoard, St Eunan's Cathedral and monastic site, and the successful development of Oakfield Park, which in 2007 won the Genius of the Place award recognising private landowners who had 'done most to revive or restore the landscape setting of a country house on a smaller estate.' Following this Oakfield has made the treasure of East Donegal available for 50,000 visitors a year to appreciate local history and beauty.
- 2. The applicant does not work in partnership with the public or agencies and his previous agreements have not been kept, as noted in the High Court in July 2020 where the applicant pursued unauthorised quarrying to the River Leannan, and 'articulated a clear intention to flout the planning laws and environmental provisions therein.'
- 3. The environmental impact study carried out in respect of this application has only been done so by the applicant—a more rounded study would take into account the impact on the local community, heritage, and wildlife and water systems, and realistic account of what is required in terms of sustainable and realistic mitigation of the difficulties arising, as well as the likelihood of these being carried out by an applicant whose track record is already shown him to be uninterested in environmental impact.

- 4. Donegal County Council is violating its own designations (an area of high sensitivity) and policies (protection of such areas) in allowing this application to go forward
- 5. The impact of the development will be harmful to another key industry of the area, which is farming, wherein landowners who farmed during the time when this site was previously quarried remember their fields being covered with dust and unusable for grazing.
- 6. There has been no options analysis offered of other possible quarrying sites which would have less environmental and historical impact and whether the current need for quarry materials can be met from other currently operating quarries with less environmental and community impact.
- 7. The blasting proposed would be harmful to the historical and public buildings of Raphoe—most especially the Royal School, Raphoe Cathedral (12<sup>th</sup> Century recently renovated through international funds), the Raphoe Central National School. I would note the Donegal County Council's designation of this area as being 'under strong urban influence' and includes worries about the many private homes, including Beechwood Estate, in less than 1 kilometre proximity from the proposed quarry.
- 8. There is considerable concern about the increase of traffic from the quarry through the small cathedral town of Raphoe, already congested at its most narrow points, and the impact of this on traffic, infrastructure, and road safety for the populace, including the school children of the four different schools located in Raphoe. This is a very real concern as Raphoe's roads are narrow and closely confined by ancient walls and byways and buildings through the town. This traffic would also carry a highly increased level of emissions from the vehicles proceeding through the town, again full of children and residents.
- 9. The impact of the noise of the quarry would have an appalling impact on the amenity and people of the area and fall outside the environmentally safe levels for noise in the community.
- 10. There are real concerns about the process that has been followed for the granting of permission by the Donegal County Council for this quarry, whether due process and proper notice of the County Council's own policies have been adhered to granting permission.

I would ask that An Bord Pleanala reject this application and support the objectors of the development of this quarry, which absolutely should not take place.
