Explanation of the Updates Carried Out

The enclosed **Summary Table** serves as an index of the updates made. In summary, the following categories of updates have been carried out:

- **Updated Owner or Occupier** – where a change in ownership [‘OWNER OR REPUTED OWNER’] or occupier [‘LESSEES OR REPUTED LESSEES’] has been brought to our attention, this is reflected in the updated Schedule.
- **Land Description Updated** – in a number of cases, for example following landowner consultation and/or recent changes in the nature or use of a plot of land, we have updated the ‘Description’ field for a particular entry in the Schedule, to reflect the more up to date situation.
- **Observation Updated** – the ‘Observation’ field was updated in one entry in Second Schedule Part 4.
- **Address Updated** – in certain cases the printed version of the original Book of Reference (February 2023) had truncated the address. This was corrected prior to property packs being issued. The printed version is now updated accordingly with addresses completed.
- **Duplication** – there were some entries that were inadvertently duplicated when printing the original Book of Reference. These duplicates have been removed.
- **Server Plan Numbers** – additional CIÉ internal referencing information included.
