Dear Sarah,

We refer to the above proposed SID application and to our previous correspondence on this matter. Please note that it is our intention to submit an application before the end of March 2023. With this in mind we would be obliged if you could confirm some details in relation to the details of the application.

Drawing Scales

For the planning drawings that will accompany the application, we have set out below the proposed scales that we feel will show the proposed development in an appropriate context and which will reduce the number of drawings and will cut down on printing. We would welcome your opinion on whether this approach is acceptable.

- **Site Location Plans.** We propose to produce these drawings at a scale of 1:10000, as in excess of 21 drawings would be required at a scale of 1:2500. The use of a scale of 1:10000 will be more informative.
- **Site Layout Drawings.** We propose to produce these drawings at a scale of 1:5000, as in excess of 100 drawings would be required at a scale of 1:500. The use of a scale of 1:5000 will be more informative.
- **Overall Site Sections / Contiguous Elevations.** We propose to produce these drawings at a scale of 1:1250 to show the proposed development in full and in context. Any relevant building elevations and details will be provided on separate drawings at appropriate statutory scales.
