Hi Richard,

As you have confirmed that stabilising or composting (transformation) of organic fines is not taking place on this site, therefore in accordance with Regulation 1069/2009 Article 2 (as stipulated below), this facility does not require an Animal By-Product authorisation;

"2. This Regulation shall not apply to the following animal by- products:

(g) catering waste, except if it:

(i) originates from means of transport operating internationally;

(ii) is destined for feeding purposes;

(iii) is destined for processing by pressure sterilisation or for processing by methods referred to in point (b) of the first subparagraph of Article 15(1) or for transformation into biogas or for composting;"

Richard Deeney here of Fehily Timoney. I am working on behalf of Oxigen Environmental.

Oxigen Environmental intends to apply to Offaly County Council for permission to develop a Materials Recovery Facility (MRF) at a site in Derryarkin, Croghan, Co. Offaly. Oxigen Environmental intends to apply for planning permission to develop a Material Recovery Facility which will accept 90,000 tonnes of waste per annum on-site. The facility will accept the following waste types on-site for processing; municipal solid waste, construction and demolition waste, mixed dry recyclable waste and commercial and industrial waste.

We are responsible for completing the planning application and EIAR for the proposed development. We have noted that Offaly County Council have made the following request in planning RFI's in recent years for similar waste related facilities:

- 'The applicant is requested to provide confirmation that they can obtain a Category 2 animal by-product permit administered by the Department of agriculture Food and the Marine'

We wish to address this matter pre-emptively. We wish to notify you that the facility does not propose accepting animal by-product for composting or a biogas production. We would appreciate it if you could confirm in writing via email or letter that an Animal By-product permit is not required in this instance.

I have attached a list of waste types to be accepted on-site as well as detailed on proposed facility processing for you information. I have also attached a preliminary site layout plan. If you need any further information regarding the proposed facility do not hesitate to get in touch.
