

A chara,

I would like to appeal the decision of Galway County Council to permit the above proposal.

Subject of Appeal - Reasons and Considerations

This is a Gaeltacht area. There is special protection for Gaeltacht areas in the County Galway Devlopment Plan 2022-2028. Chapter 13, section 13.6 clarifies this:

The Council is mindful that the county contains the largest and most populous Gaeltacht in the country which is of immense importance and requires careful consideration to ensure it is both preserved and promoted at every opportunity to ensure the long term growth and vibrancy of An Ghaeltacht.

It is evident from local people that there is concern about the potential implications of this proposal for the living standards of the people and the safety and beauty of the surroundings. Local people are concerned about noise implications, flickering light and the health of the environment. A large number of proposals have already been approved without an up-to-date assessment of their implications. Ag this point, the Irish language and the people of the Gaeltacht are vulnerable. It must be ensured, when proposals are being assessed, that proposals that would discourage people from settling in the area or encourage others to leave must not be approved. This would have a serious effect on the Irish-speaking community and on cultural affairs in the area.

The same section, 13.6, states:

Any development proposals, which in the opinion of the Planning Authority, would have a significant negative impact on the Irish language and An Ghaeltacht, will not be permitted.

I believe that the implications of this proposal for the Irish language and Gaeltacht culture have not been sufficiently studied. I believe that this proposal would have a detrimental effect on the Irish language and on Gaeltacht culture.

We recommend cancelling permission.
