Thanks for taking my call earlier and sorry for distributing your trip.

I will give you a call tomorrow but in advance of that please find some context.

I received the attached observation from TII in relation to Reg. Ref. ABP-318782-24. The application is for a windfarm in Oatfield, Co. Clare the components of which will be transported via Foynes.

The anticipated route is via the attached Turbine Deliver Route. This route is the preferred route out of a number of routes considered with in the EIAR. It takes in to account the N69 in its current form as this is a proven route used by other operators. LCCC were not able to official comment on the N18/M7 but as I understand it, are suitable for delivery subject to modifications at roundabouts etc.

The transformer is likely to be imported via Dublin.

Tracking drawings were submitted with the application from Junction 27 of the M7 to the site. I can share these with you, but it will need to be via WeTrasnfer or similar due to size. Do you have any restrictions on these types of sites?
