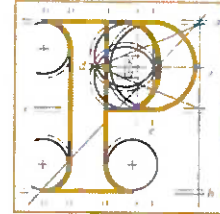

REQUEST FOR TECHNICAL ADVICE IN RESPECT OF A PROPOSED STRATEGIC INFRASTRUCTURE DEVELOPMENT

I refer to the above mentioned proposed development which is the subject of a current application for planning permission. This application has been made directly to An Bord Pleanála under the provisions of the Planning and Development Act 2000, as amended, in respect of proposed developments classified as strategic infrastructure development.

Furthermore, in accordance with Article 24 of the aforementioned Regulations and Article 215 of the Planning and Development Regulations 2001 (as inserted by Article 41 of the Planning and Development Regulations, 2006) An Bord Pleanála hereby requests you to give it technical advice on the effects of the proposed development on the risk or consequences of a major accident.


