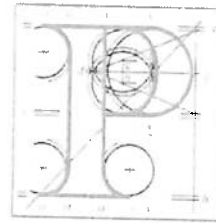

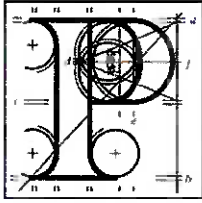



I wish to express concern about the construction of the Derrygreenagh power plant and its proximity to my land at Coole, Croghan, Co. Offaly. I have concerns over the impact this major development will have on both the value and future viability of my land in regards to agriculture and habitation.

My farm of land of 40 acres (Land Registry Folio Number OY4406F) will border the substation of the proposed development, and I have serious concerns that the large scale industrial works proposed, and future industrialisation of the area due to the proposed power plant and adjoining facilities, will adversely affect the access, usage and value of my land. It will also significantly impact the desirability of this land as a future site for housing for my children.

I have attached here a map showing the exact location of my land in relation to the proposed development, which highlights the extent to which my land borders on the development. I have highlighted my land on pages 1 and 2 of this PDF, showing how the entire southern border of my land will face the proposed Derrygreenagh substation area.
