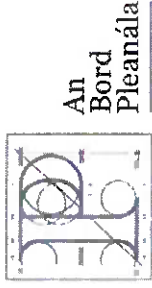

Dear Sir/ Madam,

We wish to make a submission to An Bord Pleanála, reference number: ABP-319198-24. We have serious concerns if this planning goes ahead as follows:

1. There was no consultation between the applicant and the local community.
2. The Applicant has not given adequate responses to the issues raised surrounding transport and local infrastructure.
3. Our main issue is water; section 12.2.9 of the EIAR states that, "once quarrying operations extend below the ground water table; ground water tables in the surrounding area will be lowered." We as dairy farmers depend entirely on a good supply of water from our own private well to sustain our livelihood. There was no testing or analysis of any private wells in the community surrounding the proposed quarry site.
4. Farming will be seriously disrupted, for e.g., movement of machinery between fields, which occurs daily; also movement of dairy cows across the road twice a day will be very difficult and unsafe.
5. Road safety is a major issue as roads are currently disintegrating rapidly from existing quarry, further heavy traffic will cause major problems as it is, lorries cannot pass on the narrow road and as a result ditches and drains are severely damaged.

We strongly request that the appeal be refused. We enclose the appropriate fee of €50.
