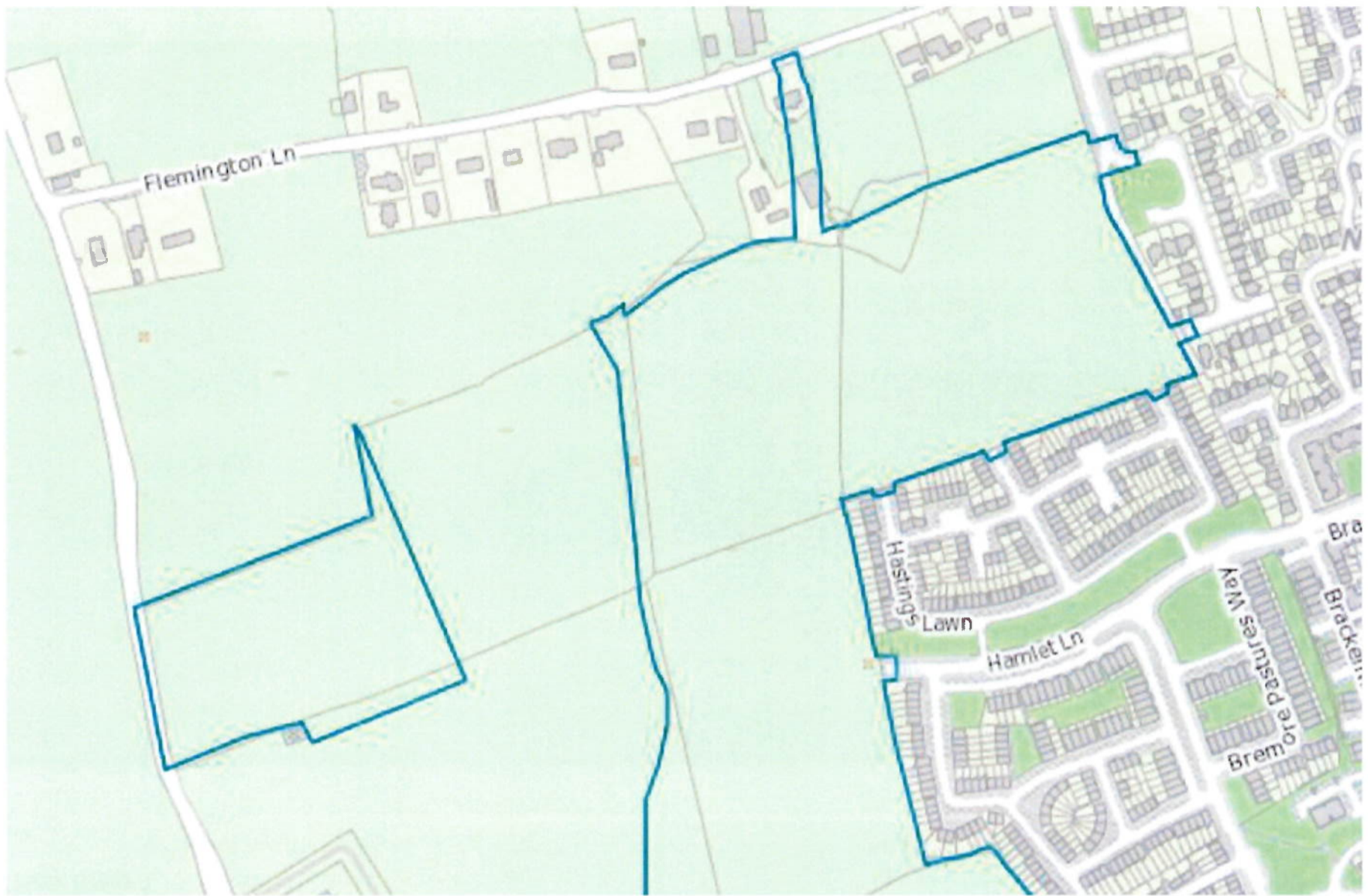
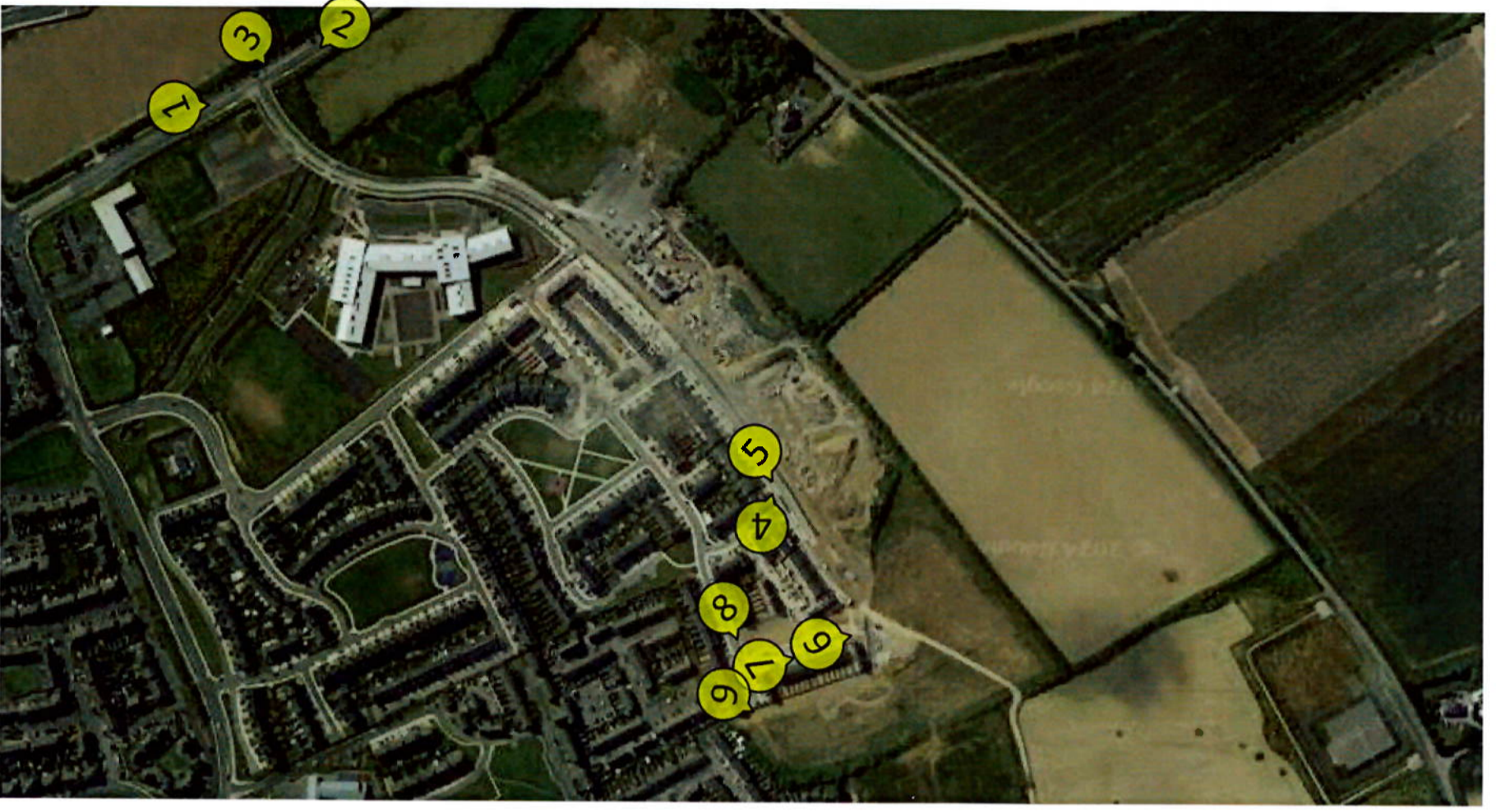


Site Location Map 2A
