RPS-KY-0877		N/A	Lookout Post	Carhoonakineely	Flat roofed concrete structure with a wide aperture that allowed the searchlight to be directed across the River Shannon. Today the concrete structure, the rusted metal drum of the lamp, and the parts of the concrete housing is all that is left.
RPS-KY-0888		Ralapane House	House	Ralapane, Tarbert	Two-storey, L-shaped residence of four bays and a porch to the front dating to the 18th century
