Notice of Planning Application to An Bord Pleanála in respect of an Offshore Wind Energy Project

On behalf of the Applicant, North Irish Sea Array Windfarm Limited, Building 3400, Cork Airport Business Park, Co. Cork, T12 AE76, we hereby submit a planning application in accordance with Section 291 of the Planning and Development Act, 2000, as amended, for planning permission for the following proposed development:

North Irish Sea Array (NISA) Offshore Wind Farm

Having regard to the nature and extent of the relevant development and any other material consideration, the Developer requests An Bord Pleanála to specify a 10 year appropriate period, within the meaning of section 40 of the Planning Acts, in respect of the proposed development, as provided for by Section 41(1) of the Planning Acts.

The proposed development is an offshore wind farm located off the east coast of Ireland. The proposed development is comprised of offshore and onshore infrastructure and will have an operational life of 35 years. The offshore infrastructure of the proposed development is located off the coast of counties Dublin, Meath and Louth. The onshore infrastructure of the proposed development is located in County Dublin (Fingal County Council and Dublin City Council administrative areas).

The Applicant is the holder of a Maritime Area Consent Ref: 2022-MAC-005 granted for the occupation of the subject maritime area for the permitted maritime usage of the construction and operation of an offshore wind farm and associated infrastructure.
