## 4 Soil Recovery Facilities

- 6. Soil recovery facilities accept uncontaminated soil waste, primarily sourced from greenfield sites, for recovery, and operate in accordance with the waste authorisation issued, i.e. waste licence, permit or certificate of registration. Materials accepted are used for backfilling, replacing soil and stone removed during previous excavations, often as a result of quarry works.
- 7. Licensed soil recovery facilities are authorised by the EPA to accept large quantities of soil and stone material (>200,000 tonnes per annum). Local authorities regulate permitted and registered sites which are permitted to accept up to 200,000 and 25,000 tonnes, respectively. Permitted and registered sites operate under a lifetime capacity (of 5 years) (Draft National Management Plan for a Circular Economy, 2023).

### 7 Landfill

#### 7.1 Municipal waste

- 11. The number of landfills accepting municipal waste for disposal has continued to decrease in Ireland, with latest figures indicating a decrease from 29 in 2007 to 3 facilities currently operational / accepting waste in Ireland (all privately-owned and operated). The following operational municipal landfills are situated within the EMR, and their respective waste management capacities (EPA, 2022)<sup>2</sup> are noted:
  - Knockharley Landfill (W0146-02) County Meath:
    - Total capacity for waste accepted for disposal (maximum tonnes per annum) 175,000;
    - Waste types accepted for disposal (maximum tonnes per annum) 100,000 household,
       45,000 commercial, and 30,000 industrial;
    - Waste types accepted for recovery (maximum tonnes per annum) 25,000 construction & demolition and 70,000 inert waste.
  - Drehid Landfill (W0201-03) County Kildare:
    - Total capacity for waste accepted for disposal (maximum tonnes per annum) 175,000;
    - Waste types accepted for disposal (maximum tonnes per annum) 120,000 non-hazardous municipal, commercial and industrial wastes;
    - Waste types accepted for recovery (maximum tonnes per annum) No limit for inert waste where used in landfill engineering.
  - Ballynagran Landfill (W0165-02) County Wicklow:
    - Total capacity for waste accepted for disposal (maximum tonnes per annum) 175,000;
    - Waste types accepted for disposal (maximum tonnes per annum) 62,500 household, 67,500 commercial, and 45,000 industrial;
    - Waste types accepted for recovery (maximum tonnes per annum) 28,000 construction & demolition.
- 12. Licence schedules can be accessed through the EPA<sup>3</sup> for more detailed information on waste acceptance criteria and capacity at each facility.

#### 7.2 Inert Waste

- 13. Active inert facilities in Ireland are all located in the Eastern-Midlands Region with no inert landfills in the Southern or Connacht-Ulster Regions.
- 14. Inert landfill facilities accept wastes which comply with the waste acceptance criteria limits for inert landfills as described in the EU Landfill Directive. The currently licensed inert landfill facilities in Ireland are:
  - Integrated Materials Solution (IMS) (W0129-02) County Dublin;

- Walshestown Restoration (W0254-01) County Kildare;
- Kyletalesha Landfill (W0026-03) County Laois.
- 15. In addition, Boliden Tara Mines Limited (P0516-04) located County Meath is not an inert landfill, however, the site's waste acceptance criteria, as per the IE Licence for Tara Mines, includes waste acceptance of greenfield and non-greenfield soil and stone for backfill.

#### 7.3 Non-hazardous soil and stone

16. Non-hazardous soil and stone is material that does not meet acceptance criteria limits for hazardous or inert waste (as described in the EU Landfill Directive). Currently there is only one landfill accepting non-hazardous soil and stone; Corranure Landfill (W0077-04) in County Cavan. This site previously accepted municipal waste, but has not done so in recent years and now only accepts material to complete cell capping and profiling. No soil and stone waste is accepted at the site for disposal.

## 8 Waste facility permit and certificate of registration holders

- 17. There are a number of facilities within the EMR and County Dublin which hold a Waste Facility Permit (WFP) or Certificate of Registration (CoR). These facilities accept soils and inert waste from C&D activities. The WFP and the CoR database is a register for WFPs and CoRs issued by local authorities under the Waste Management (Facility Permit and Registration) Regulations, S.I. No. 821 of 2007, as amended.
- 18. The National Waste Collection Permit Office (NWCPO) provides access to this database, where WFPs and CoRs that have been granted, reviewed, revoked and expired can be reviewed. Suitable facilities / permit holders can be identified via the NWCPO database at pre-construction / construction stage These facilities can provide an avenue for acceptance of permitted quantities soil and inert waste from C&D activities, such as those associated with the proposed development.

#### 9 Waste Collection Permit Holders

- 19. All waste collectors in Ireland must have a valid waste collection permit to operate legally. There are an extensive level of permitted waste collectors operating within the EMR and County Dublin which hold a Waste Collection Permit. The NWCPO provides access to a database, where granted, reviewed, revoked and expired Waste Collection Permits can be reviewed.
- 20. Suitable waste collection permit holders can be identified via the NWCPO database at pre-construction / construction stage. These permit holders can provide waste collection and transport services of waste generated from activities associated with the proposed development.
