3. WHERE POSSIBLE, THE ACROTELM SHALL BE STORED WITH THE VEGETATION PART OF THE SOD FACING THE RIGHT WAY UP TO ENCOURAGE GROWTH OF PLANTS AND VEGETATION AT THE SURFACE OF THE STORED PEAT WITHIN THE PEAT STORAGE AREAS
4. ALL PLACED MATERIAL WILL BE ALLOWED TO REVEGETATE NATURALLY FROM THE EXTENSIVE SEED SOURCE OF THE PLANTS THAT HAVE ALREADY COLONISED IN THE AREA. PLANTING ACROSS THE AREA MAY OCCUR BETWEEN 3-5 YEARS AFTER PLACEMENT, ASSUMING THE GROUND HAS STABILISED AND IS NOT WATERLOGGED.
5. BOG MATS TO BE USED WHERE NECESSARY TO FACILITATE PLANT & MACHINERY ACCESS OVER EXISTING SOFT GROUND. NOTE, PLANT & MACHINERY NOT TO TRAVERSE PLACED PEAT.
