Hi lain,

Please find response to your request below and attached - I can provide the publicly available abstractions register in response to your request. The EPA Abstractions Register is not published on EPA Maps. In accordance with the protection of critical national infrastructure direction included under the EU Directive 2016/1148, the publicly available abstractions register data do not include those water abstractions where the abstraction purpose has been identified as being for drinking water. To establish drinking water abstractions for your area of interest, you could consult with the relevant local authorities, Group Water Schemes, Irish Water etc.

Note that the EPA Abstractions Register only includes those abstractions registered and that are 25 m<sup>3</sup>/d or more. To find information about abstractions less than 25 m<sup>3</sup>/d, the following data sources may be relevant – conduct a local field survey, consult with the relevant local authorities, Group Water Schemes, Irish Water etc.

In accordance with Article 6 of the Regulations (S.I. 261 of 2018), the Environmental Protection Agency may share information on abstractions, with the exception of personal information, with persons or public bodies, so they can satisfactorily discharge their statutory functions. The information / data provided have been generated from the Environmental Protection Agency's Water Abstraction Registration Database and relate to those water abstractions of 25 cubic meters (25,000 litres) or more per day that have been registered with the Environmental Protection Agency. In accordance with the protection of critical national infrastructure direction included under the EU Directive 2016/1148, the data do not include those water abstractions where the abstraction purpose has been identified as being for drinking water. Additionally, grid references are rounded to the nearest kilometre to protect the identity of individual households and businesses, who may also use the abstracted water for private domestic use. I don't use the WFD app — I think it may just be for public authorities but you could send an enquiry to the catchments team at https://www.catchments.ie/contact/

The national monitoring stations are up to date on the map but not all stations are on current or past monitoring programmes or have data associated with them (even if they are marked as operational/surveillance).

The stations that are on the EPA monitoring programme for the R.Flesk are below.

Hi Jean,


I hope you don't mind me contacting you directly. You were able to give me a few pointers regarding EPA water quality data a while back and I hoped you'd be able to help me again. A few queries I have are:

- I was looking at EPA online mapping (the National Water Monitoring Stations layer) and wondered if
  data is available from any specific station that is currently noted as Operational or Surveillance or
  only a select few? I am specifically interested in water quality on the River Clydagh south-east of
  Kilarney, Co. Kerry (according to EPA mapping layer 'WFD River Sub Basins', the stations are
  located within FLESK (KERRY)\_040, FLESK (KERRY)\_030, FLESK (KERRY)\_020, and FLESK
  (KERRY)\_010 sub-basins).
- Have any new monitoring stations been installed on the Clydagh River or in the downstream catchment, or are the stations shown on the National Water Monitoring Stations layer up-to-date?
- Is there a way to find out when these stations began monitoring?

 Also, can you advise on how to obtain access to the Water Framework Directive Application (WFDApp), or is it only available to public authorities?

I refer to the request which you made under under the European Communities (Access to Information on the Environment) Regulations 2007 to 2018 (S.I. No. 133 of 2007, S.I. No. 662 of 2011, S.I. No. 615 of 2014 and S.I. No. 309 of 2018) (hereafter referred to as the AIE Regulations) for access to information held by Inland Fisheries Ireland (IFI) relating to:

'McCloy Consulting have been commissioned to undertake an assessment of the water environment (including water quality assessment) as part of an EIA for a proposed development in Co. Kerry (see below – site centroid: 520889, 583475).

As part of this assessment, we wish to obtain information on the water environment potentially held by IFI that will inform our work. We also wish to pre-empt any concerns that IFI may raise when consulted on the EIA Report and highlight any potential constraints to the development. Therefore, we would be grateful if IFI could provide further information if available, including:

- Any details of known pollution incidents in the vicinity of the development site (IFI prosecutions or warning letters)
- Details of any salmonid or other fishery related designations for all watercourses in the vicinity of the site and any downstream catchments of the site
- Details of any water quality monitoring/fish habitat surveys undertaken by IFI in the vicinity and/or downstream of the proposed development site, and any associated data
- Advise any further considerations that are deemed appropriate for a water environment assessment at the site from IFI's perspective.

#### **Summary of Decision**

I made a decision on your request today, February 10<sup>th</sup>, 2021. Following identification of one record which relates to your request, I have decided that you should be granted access to this record. I have also enclosed a schedule with this correspondence which shows the document(s) that I consider relevant to your request. It also provides a brief description of the document.

I have also included further information below as requested:

- Any details of known pollution incidents in the vicinity of the development site (IFI prosecutions or warning letters)
  - IFI produces annual reports containing information on environmental prosecutions. These reports are published on the IFI website <a href="https://www.fisheriesireland.ie">www.fisheriesireland.ie</a>
- Details of any salmonid or other fishery related designations for all watercourses in the vicinity of the site and any downstream catchments of the site
  - This is a prime salmonid catchment. Other protected fish species occur in the system including lamprey and European eel.
- Details of any water quality monitoring/fish habitat surveys undertaken by IFI in the vicinity and/or downstream of the proposed development site, and any associated data
  - Please see summary output record provided for a stock assessment survey which was undertaken in 2000. The apparent absence of salmon at the immediate site (which was not surveyed due to a lack of access) may be due to the presence of a barrier or unsuitable spawning/nursery habitat. Good salmon rod catches and high densities in 2000 has meant that fish stocks (salmonids) in the catchment are deemed as being in good status.
- Advise any further considerations that are deemed appropriate for a water environment assessment at the site from IFI's perspective.
  - A more detailed appraisal of available IFI and other self-service environmental resources is required to establish the status of this site. Electrofishing of the site should be undertaken to determine species present and their densities.

# **Right of Review**

Under Article 11 of the AIE Regulations you have a right to request an internal review of a decision. An internal review involves a complete reconsideration of the matter by a member of the staff of IFI, unconnected with the original decision, of the same or higher rank than the original decision maker, who may affirm, vary or annul the original decision.





Please find attached the decision letter relating to your recent AIE request (Ref AIE-021-001-IFI)

I have also attached the decision schedule and record falling under the scope of your request

Following engagement with the IFI Research Department in relation to your request I have included their comments below:

- The Flesk/Laune complex, into which this tributary flows, is one of the most productive commercial and recreational angling salmon catchments in the country <a href="https://www.fisheriesireland.ie/Salmon-Management/wild-salmon-and-sea-trout-statistics.html">https://www.fisheriesireland.ie/Salmon-Management/wild-salmon-and-sea-trout-statistics.html</a> Both MSW salmon and 1 SW salmon are taken in the catchment.
- 2. Lough Leane, into which the Flesk flows, is one of the best brown trout fisheries in the country. It also supports a unique population of shad, the Killarney shad, which is highly protected. Both salmon and Killarney shad are listed under Annex 2 of the Habitats Directive.
- 3. In wetted area terms the Flesk/Laune complex is one of the largest in the country (12<sup>th</sup> of 172 catchments) in terms of accessible salmon habitat and is well endowed with quality salmonid spawning/nursery habitat which supports some excellent densities of salmon and trout.



We propose to undertake strategic water quality monitoring throughout the year to inform baseline conditions. We are aware that the lower catchment has been subject to historic nutrient pollution. If the Council had any specific comments regarding water quality monitoring / pollution, these would be welcomed. We will also liaise with EPA on these matters.

Hi lain.

Please find the requested information attached.

I ran the queries on our habitat and species data for the area of the study area shapefile, apart from the freshwater pearl mussel shapefile which holds the records for the entire Laune catchment. Can I just remind you of the sensitivity of *Margaritifera* data owing to the on-going risk of pearl fishing and other deliberate damage. Consequently, these data should not be made available to the public, either electronically or in hard copy, in a format (e.g. as a large scale map) that could readily be used to locate mussels.

One thing I meant to mention last week - Killarney National Park, Macgillycuddy's Reeks and Caragh River Catchment SAC 000365 has Site Specific Conservation Objectives written that can be downloaded from the Protected sites section of our website. - Two nest sites known since 2002 recorded in W08, one of them occupied
- Two nest sites, one of which a known nest site since 2002, recorded in W28 (one not occupied, the other not surveyed in 2017)

Species records are provided as both Excel file and shapefile (in Irish Grid TM75). Records are represented as squares in the shapefile, with the side lengths of the squares corresponding to the resolution (1x1m to 10x10km) in which the observations were recorded. Please beware that any records overlapping the area of interest were extracted, and that the dataset contains many historic records that have been recorded on a 10km square (hectad) level and may be from locations outside of the area of interest.

Just to reiterate, as per the data policy, our datasets are not complete or perfect in terms of quality, so it is important to note that the absence of information in the NPWS dataset for an area, does not necessarily imply a low biodiversity value for that area. These data should not be seen as a replacement for field surveys.

Please note that the NPWS species dataset is incomplete, particularly for fish, bats and birds. Can I also remind you that locations for sensitive species should not be made publicly available.

The list of what qualifies as a rare or threatened species is available at

It covers species listed one or more of the following documents: EU Directives (Birds & Habitats), Wildlife Act, 1976 & Wildlife (Amendment) Act, 2000, Flora (Protection) Order 1999 or Published National Red Lists. This list is regularly updated, as new legislation is added, or red lists are published, so it is worth checking back to the version available on the NPWS website regularly.

I am wondering did you have a look at the GIS data for Annex habitats and species from the 2019 Article 17 (EU Habitats Directive) submission? These data are available for download from <a href="https://www.npws.ie/maps-and-data/habitat-and-species-data/article-17/2019">https://www.npws.ie/maps-and-data/habitat-and-species-data/article-17/2019</a>, and would be a good first port of call for any data on Qualifying Interests for the area.

Most but not all Annex Habtiats/Species would be covered by these downloads. For information on fish species we would ask you to get in contact with Inlands Fisheries Ireland (IFI).

Data on sensitive species are also not provided in full resolution in the downloads. I checked our Freshwater pearl mussel records for the area, and we have no records for the Clydaghroe River.

If you are interested in Freshwater pearl mussel data from the wider area (i.e. the Laune catchment), or any other sensitive species data for the area, could I ask you to send me a data request form please (it seems you email from last month didn't get through to us).





As part of this assessment, we wish to obtain information on the water environment potentially held by NPWS that will inform our work. We also wish to pre-empt any concerns that NPWS may raise when consulted on the EIA Report, and highlight any potential constraints to the development. Therefore, we would be grateful if NPWS could provide further information if available, including:

- Details of any know pollution incidents in the vicinity of the development site.
- Environmental datasets for the surrounding area e.g.
  - water quality,
  - protected sites / species.
- Advise on any further information the developers should be aware of.

We propose to undertake strategic water quality monitoring throughout the year to inform baseline conditions. We are aware that the lower catchment has been subject to historic nutrient pollution.
