Dear Sir/Madam,

In relation to the above proposed development (your ref: ABP-315920-23), we wish to seek your feedback/approval for suggested drawing scales, which we propose for use in the Planning Drawings which will accompany the application (submission not yet made).

We wish to agree the below suggested scales for this application as we believe that this approach will show the proposed development in an appropriate planning context and will reduce the need for excessive drawings (which would otherwise be required based on the current guidelines for planning drawings).

Thank you for your recent response re. drawing scales and submission of drawings for the above project, but we would like to politely ask again if the original proposed scales be considered? We believe that the proposed scales show the proposed development in an appropriate context due to the scale and nature of the proposed development site, whilst also significantly reducing the number of printed A1 drawings required for submission.

The Board has previously agreed to these scales and I understand there were no issues with these drawings with regards to legibility, context, or level of detail. These drawings all contain a site location key plan and will be accompanied by an overall, Site Master Plan drawing, showing the full site on one drawing.
