Galway County Council issued a notice under section 261a on 3<sup>rd</sup> August, 2012 in relation to the above quarry directing them to apply to the Board for substitute consent which was to be accompanied by a remedial Environmental Impact Statement and a remedial Natura Impact Statement not later than 12 weeks after the date of the notice. **Board Reference 07QB0238.**

An application was made to the Board requesting an extension of time under section 177E(4) of the Planning and Development Acts, 2000-2010, as amended. The Board granted an extension of time up to the 7<sup>th</sup> May, 2013 for lodging an application for substitute consent. **Board Reference : 07SH0082**

The applicant made a request to enter into pre-application consultation in relation to the substitute consent with the Board. The Board refused this request on the 4<sup>th</sup> January, 2013. **Board Reference : 07SI0006.**

An Application for substitute consent was received by the Board on 7<sup>th</sup> May, 2013 and a copy of the substitute consent issued to the Planning Authority 10<sup>th</sup> May, 2013, the CD issued 13<sup>th</sup> May, 2013. **Board Reference: 07SU0038.**

The planning authority received the application 13<sup>th</sup> May, 2013 as per proof of delivery on file. The last date for receipt of a report from the planning authority is 22<sup>nd</sup> July, 2013.

An observation has been received from Catherine O Ceoinin on 9<sup>th</sup> May, 2013.

Following instructions and validation by the Inspector dealing with this file a notice issued under section 131 of the Act to the following prescribed bodies: An Taisce, The Heritage Council, Udaras na Gaeltachta, The Department of Community Equality



and Gaeltacht Affairs, Inland Fisheries Ireland, Department of Communications, Energy and Natural Resources. DAU- Department of Arts Heritage and the Gaeltacht.

No responses have been received.
