An Bord Pleanála Case Number: ABP-312016-21. On 22nd November 2021, Rowanmere Limited formally asked An Bord Pleanála, through the pre-application process, if a windfarm development with a total output greater than 50 megawatts in the vicinity of Ballynalacken County Kilkenny would be considered strategic infrastructure development. Subsequently 3 No. pre-application meetings took place between February 2022 and September 2022. The pre-application process was closed out by letter from An Bord Pleanála on 24th April 2023. The letter formally served notice that the proposed development falls within the scope of paragraphs 37A (2)(a), (b) and (c) of the Planning & Development Act 2000 (as amended). Accordingly, the Board decided that the proposed development would be strategic infrastructure within the meaning of section 37A of the Act. Any application for permission for the proposed development must therefore be made directly to An Bord Pleanála under section 37E of the Act.
