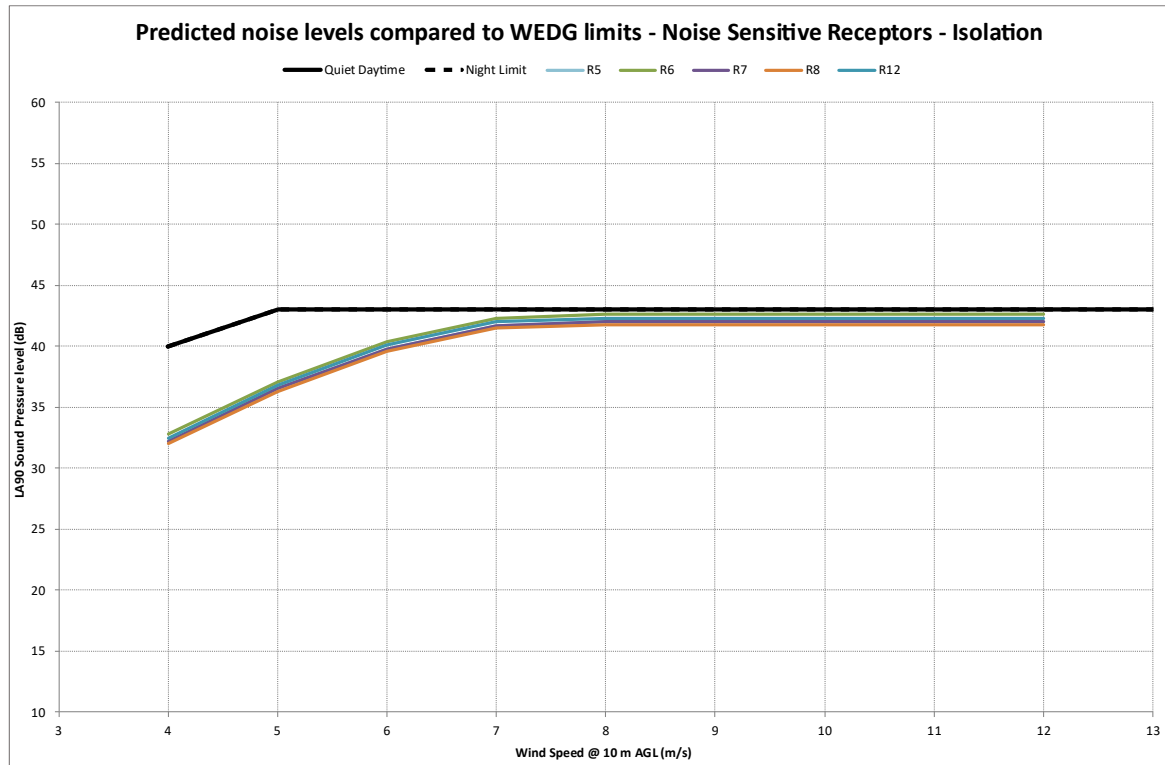


Figure 1-1: NML1 – Proposed Development in Isolation

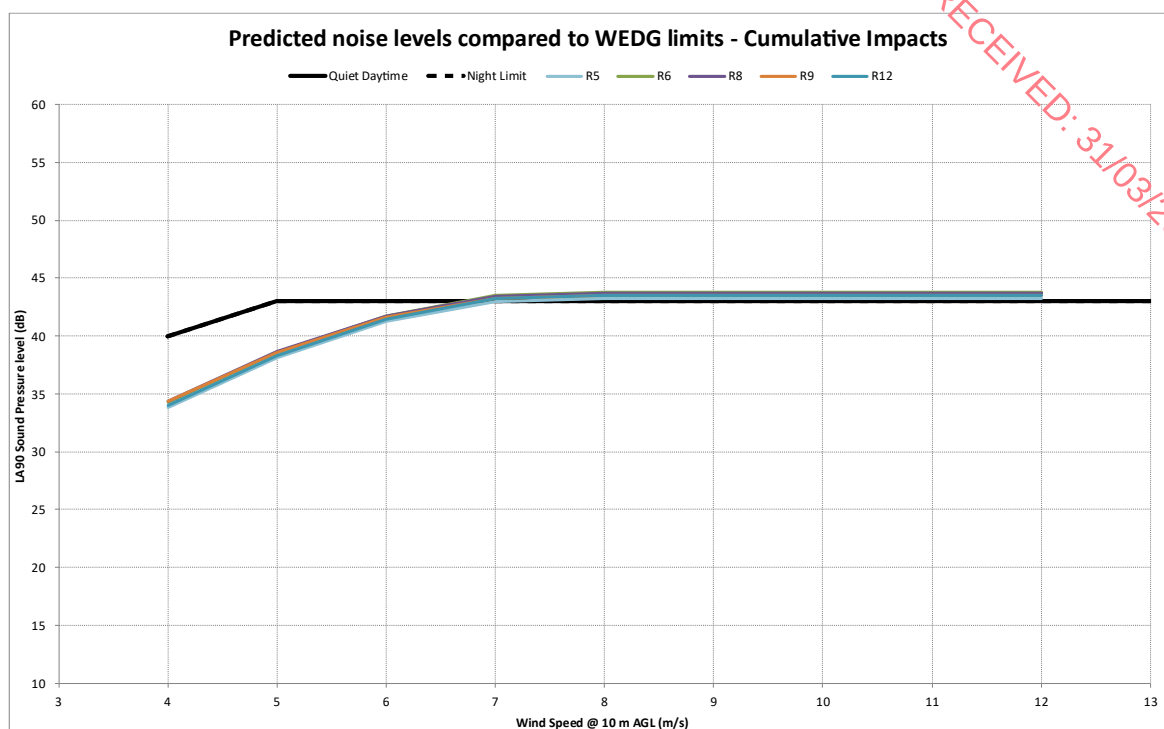


Figure 1-2: NML1 – Proposed Development Cumulative

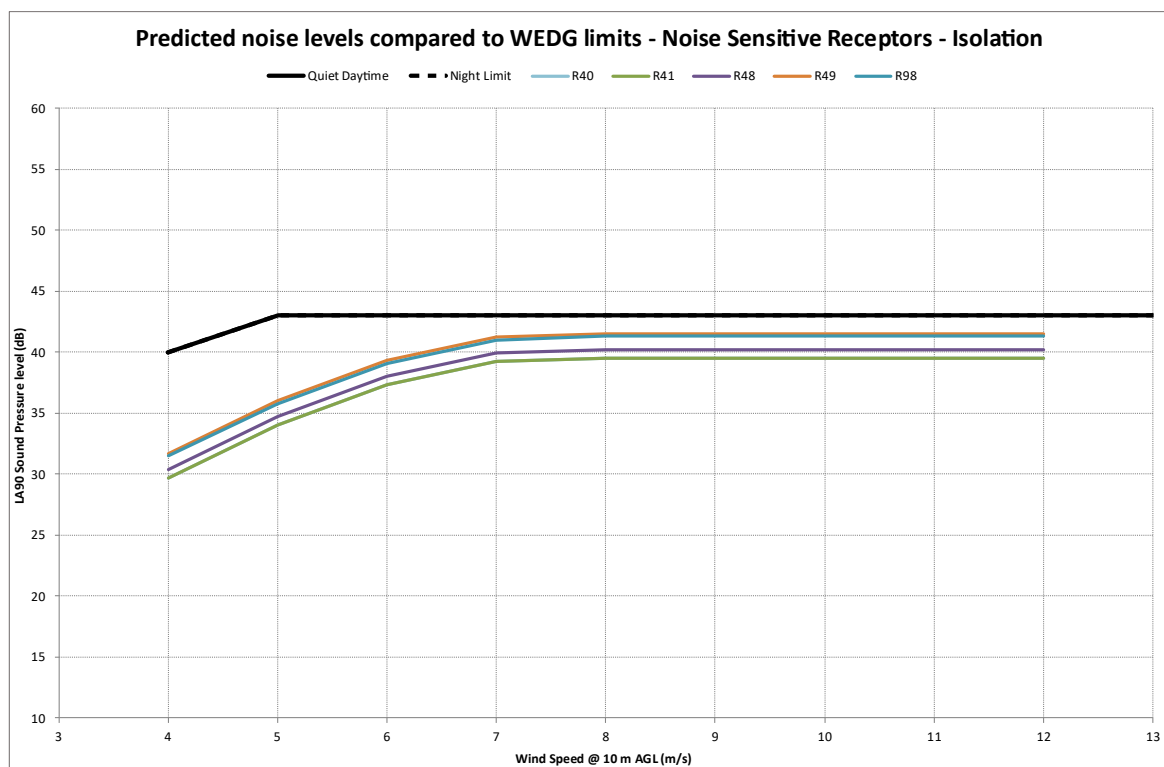


Figure 1-3: NML2 – Proposed Development in Isolation

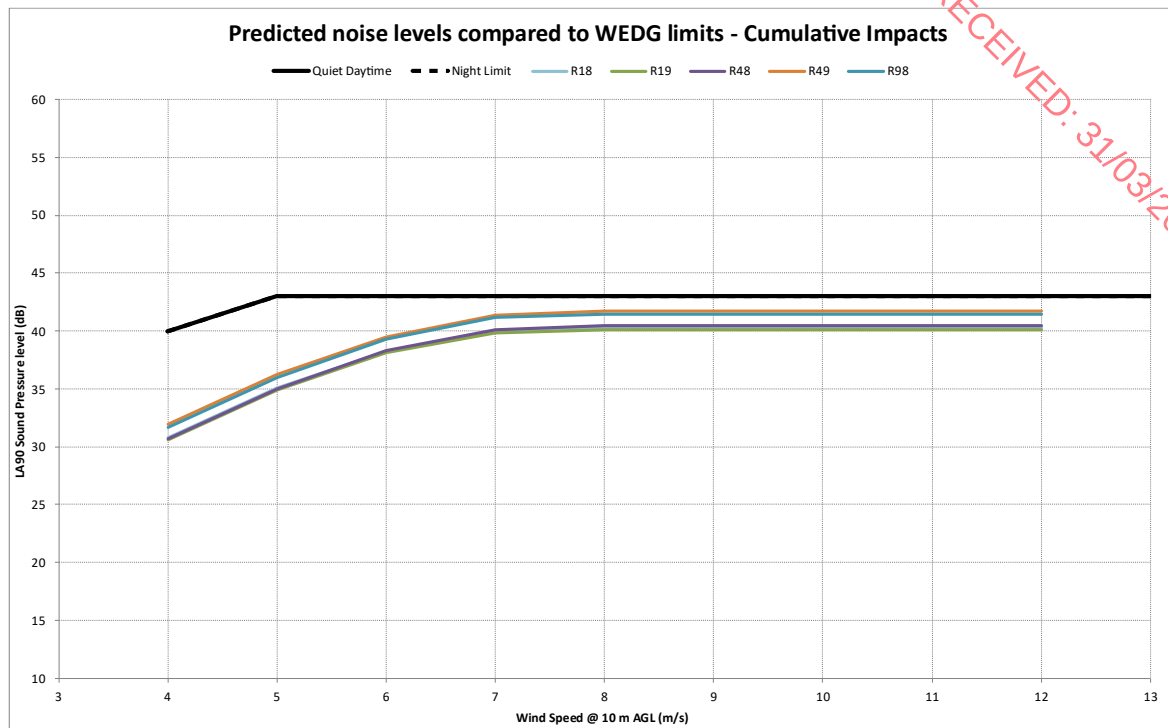


Figure 1-4: NML2 – Proposed Development Cumulative

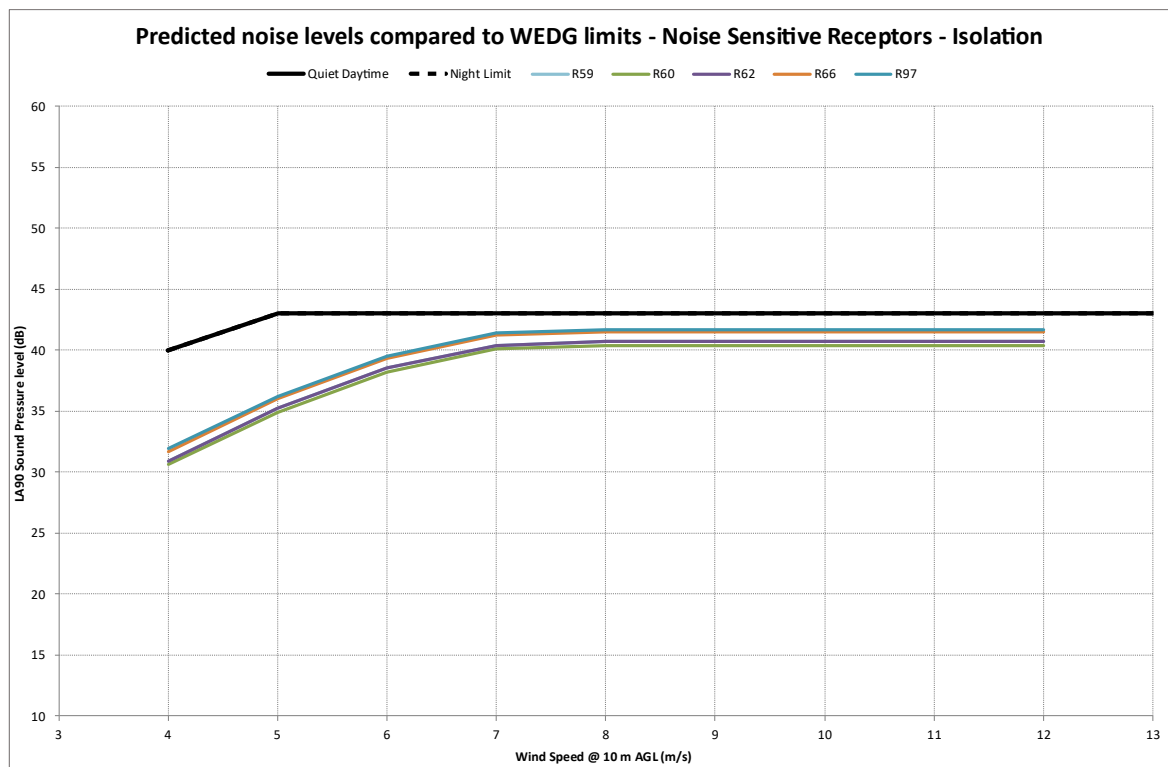


Figure 1-5: NML3 – Proposed Development in Isolation

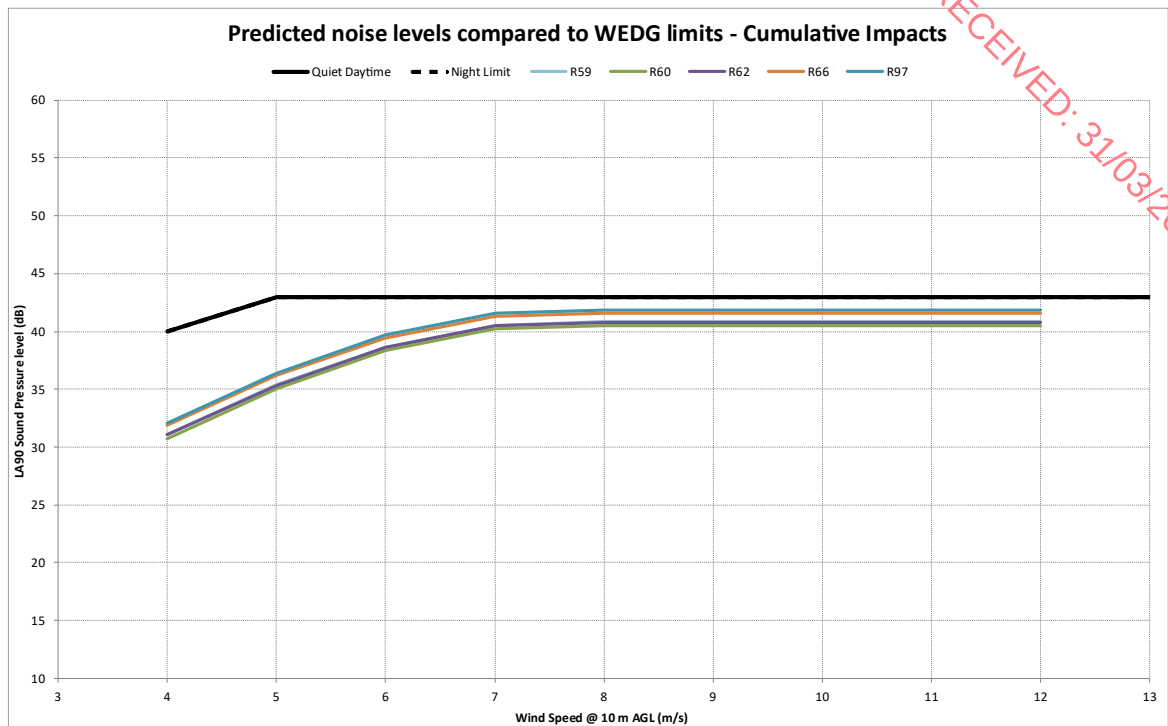


Figure 1-6: NML3 – Proposed Development Cumulative

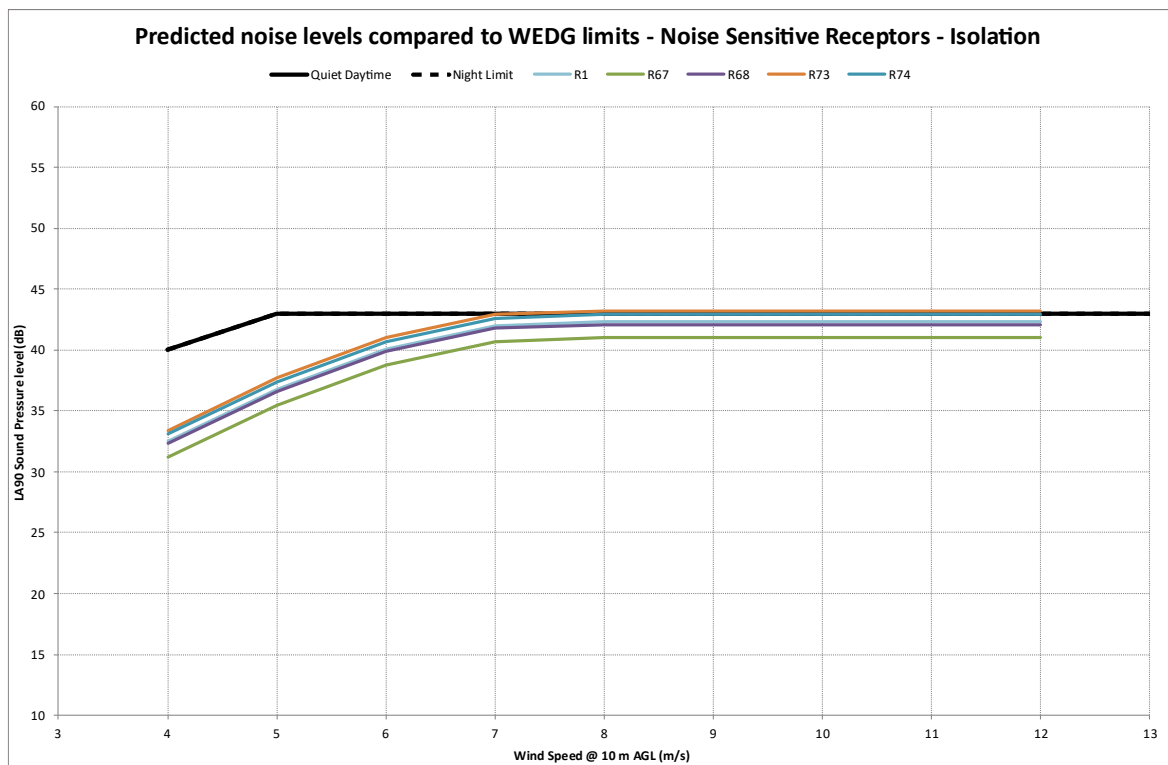


Figure 1-7: NML4 – Proposed Development in Isolation

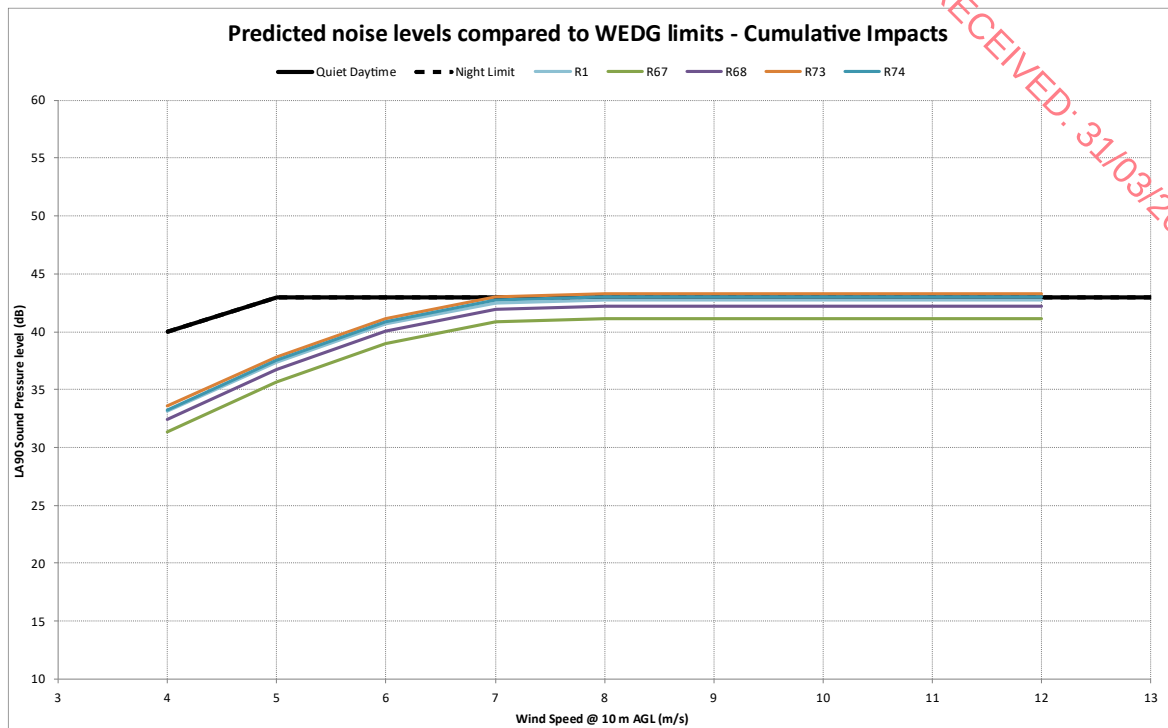


Figure 1-8: NML4 – Proposed Development Cumulative
