development will consist of:
Attic conversion for storage
including a rear dormer.
Conversion of existing garage
for extended living with new
window to front elevation. The
planning application may be
inspected or purchased at a fee
not exceeding the reasonable
cost of making a copy, at the
offices of the Planning Authority
during its public opening hours.

Application to An Bord Pleanála
for permission in relation to a
development of land; Section
37L of the Planning and
Development Act, 2000. I, JJ
Flood & Sons (Manufacturing)
Ltd., intend to apply for
permission under section 37L of
the Planning and Development
Act 2000 for development at this
site. The development is located
in the townland of Murrans,
Oldcastle, Co Meath, A82 R6A0
(ITM 652523 774771). The Site
has origins prior to 1963. An
application for substitute
consent, under section 177E of
the Planning and Development
Act 2000, as amended, is
currently with An Bord Pleanála
reference 322189-25. The
development consists of the
removal of existing stockpiles
from across the Site (ca.
40.12ha), the extraction and
processing of gravel and soft
rock by mechanical means over
an area of ca. 6.35ha within the
Site, including a new extraction
area in a greenfield area of the
Site (ca. 1.02ha), all to a pit floor
of ca. 119m O.D., the
continuation of use of the Site
and all infrastructure for 20 years
along with a modified restoration
plan. The Site is comprised of
the following infrastructure for
continued use: Existing plant -
Dry mobile screening, wet semi-
mobile screening, semi-mobile
crushing plant; Water
management system -
settlement canal system;
associated settlement ponds;
Stockpiles of aggregate; Site
access road, on-site haulage
routes, site office and toilets (ca.
77m2); wastewater treatment
and percolation; storage shed
(ca. 375m2); maintenance Shed
(ca. 164m2); two fuel tanks (ca.
153m3); vehicle parking;
weighbridge; and, aggregate
additives for making arena
footing. The application is
accompanied by an
Environmental Impact
Assessment Report ('EIAR').
Submissions or observations
may be made on the application
and the EIAR, to An Bord
Pleanála, 64 Marlborough Street,
Dublin 1, www.pleanala.ie
without charge. Submissions or
observations must be in writing
and made within the period of 8
weeks beginning on the date of
receipt of the application by An
Bord Pleanála and such
submissions and observations
will be considered by An Bord
Pleanála in making a decision on
the application. An Bord
Pleanála may grant the consent
subject to or without conditions
or may refuse to grant it. The
application for consent and the
EIAR may be inspected, or
purchased at a fee not
exceeding the reasonable cost
of making a copy, at the offices
of An Bord Pleanála, or the
relevant planning authority
during its public opening hours.

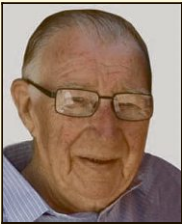
