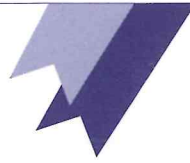


- (i) the beneficial owner of the Grantee's interest in 22 Agreements for Option for turbine leases with the landowners listed in the First Schedule hereto **and**
