In accordance with Section 51(2) of the Roads Act, 1993 (as amended), Donegal County Council made an application to An Bord Pleanála on the 23rd of September 2021 for approval to carry out the following proposed development which is located at Station Road, Lifford, County Donegal and partly within the adjoining foreshore:
