Summary Response

EIAR Addendum

An EIAR Addendum has been provided to address a change in design of the project in Strabane. As you are aware, there has been a change to the design of the proposed park on the Strabane side, which has arisen due to an issue with land acquisition. Therefore, a revised EIAR has been provided with all revisions set out in the enclosed EIAR Addendum.

Updated Plans

Please note that a revision has been made to the red line boundary of the planning application in response to a request for further information. The new red line boundary has been extended to take into account temporary bridge construction works within the Foyle River.

As set out previously, the proposed Riverine Community Park and associated Pedestrian Bridge will be of local and regional importance. It will be delivered under an EU Funding Programme, with the deadline for funding significantly constrained for this project (the funding programme ends December 2023 therefore dictating a construction end date of Q3 2023).
