Note No 1: With construction phase mitigation, the impact is short term - mainly disturbance from construction traffic and noise – intermittent over a period of 36 months. Livestock can be maintained on the land. The main mitigation measures listed in 14.6.2 of the EIAR include notification to landowners in advance of commencement of works, provision of adequate fencing, provision for adequate access to the retained lands, provision for adequate water and controlling dust.
