I refer to the letter received from An Coimisiún Pleanála on 5<sup>th</sup> March 2025 in relation to the Laurclavagh wind farm development (ACP 319307-24). On behalf of our client, Laurclavagh Ltd. (the Applicant), MKO have prepared a detailed response to the Further Information Request issued by An Coimisiún Pleanála under Pl. Ref. 319307, dated 5<sup>th</sup> March 2025, for the proposed 8 no. wind turbines and associated works located in Laurclavagh and adjacent townlands, Co. Galway.
