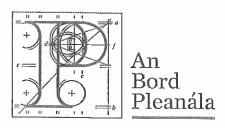

Dear Sir /Madam,

With regards to will matter I can confirm that I have been instructed to act on behalf of the above named landowner. My Client has instructed me to object in the strongest possible manner to the scheme as currently being proposed as it will mean that the property will now have the public road and in particular the bus corridor much closer to the property which will lead to the property being over looked with a consequent loss in privacy and a increase in noise and air pollution to the property.

The loss of the lands included in the Compulsory purchase order will also mean that there will be a consequent loss of parking for vehicles in front of the property. The scheme will also create a traffic hazard as vehicles entering and leaving the property as the location of the bus stop just south of the entrance will create a obstruction of the view of traffic coming out of town. It will also mean that to exit the property in a vehicle to turn right, will mean having to stop on a footpath and /or a cycle way which is a unsafe maneuver and in our view the scheme should not be allowed to create a hazard for my Client or other road users.

For these reasons my Client has instructed me to object in the strongest possible manner to this scheme as it is currently proposed for the reasons set out above and also that it is a infringement of my Clients constitutional right to the quiet enjoyment of his property.
