



To Whom It May Concern:

I write to An Bord Pheanála to strongly urge the Board to reject the Compulsory Purchase Order (CPO) on Ayrfield Drive, Ayrfied, Dublin 13 thus allowing for an opening of the wall on Ayrfield Drive to allow for pedestrian and cycle access into the Ayrfield estate and which connects us directly to a dual-Carriageway onto the Malahide Road.

Having spoken to many local residents from the estate over the past few weeks and consulted with them on this matter it is extremely clear from the community that no residents from within the estate would support the new access route for the estate as many prefer to choose one of five other access routes already available to them from the estate versus the potential knock on impacts this will cause the estate as set out below:

Loss of a Greenspace - This Greenspace provides local children a place to play and interact. If this was lost the children would be forced to play on the adjacent roads as no other greenspace is close in proximity to Ayrfield Drive.

Security Issues - With the proposed opening from Ayrfield Drive onto the Malahide Road this will cause security concerns to residents of the estate. Having spoken to our local Garda Station regarding this matter this will make policing the estate more difficult and allowing for an additional exit point will allow for ease of quick exit for any potential criminal activity from the estate.

Safety of Children - The safety of children will be seriously compromised if the wall is opened to allow for access. A well serviced dual carriageway and the main artery of public & private transport for the constituency. The potential loss of life cannot be discounted as this will make many parents wary of allowing their children to play in the estate. This will cause a vulnerability to the community that hasn't been seen before in the 40 years the estate has lived comfortably with children playing with the confines of the area.

Car Parking Concerns - By allowing access to the Malahide Road from Ayrfield Drive we will see similar to local Dart Stations in Raheny, Kilbarrack & Harmonstown the car parking issues adjacent to these locations causing serious problems to local residents. Ayrfield Drive and adjacent roads will be turned into a carpark to allow people to get the bus from the Malahide Road.

Finally, I would again urge the Board to reject this CPO of land and side with local community in Ayrfield and Rathvale Parish. Thank you for taking into consideration my opinions on this
