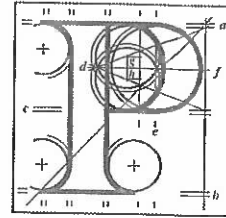

The Department Housing, Local Government and Heritage ("the Department") refers to correspondence received in connection with the above. Outlined below are heritage-related observations/recommendations co-ordinated by the Development Applications Unit under the stated heading(s).

Nature Conservation

Having considered the documentation supporting this application, it is noted that to facilitate the proposed road development it is intended to remove 228m of hedges and 221 trees from treelines. While the incorporation of 545 trees and 2995m of hedgerow in the landscaping of the proposed development should ensure there will be no long-term loss of biodiversity as a result of this vegetation clearance, the felling of trees and removal of hedges during the bird breeding season which could lead to the destruction of nests, eggs and nestlings, should be avoided.

Recommendations

In the light of the above the Department recommends that any planning permission granted in response to the present application should be subject to the following conditions:

1. That no removal of trees or vegetation shall occur during the main bird breeding season from March to August inclusive.

Reason: To avoid the destruction of bird nests, eggs and nestlings.

In the event that additional heritage-related observations become available before the deadline date, a further letter will issue.
